BACKGROUND: Franklin County Treasurer's office has been using Garda Armored car as a carrier service to deliver bank deposit bags to Umpqua (county bank), as well as to bring bank bags with change orders back to the county. On July 2019 the cost of service with Garda went up from \$484.00 to \$625.90 a month resulting in an annual increase of \$1702.80. Loomis provides similar service as Garda and is currently on a State contract with Washington State Department of Enterprise Services. Cost of service with Loomis would be \$451.93 a month per the state contract.

RECOMMENDATION: Franklin county Commissioners approve the resolution to adopt Loomis as the new Armored car carrier for Franklin County.

Attachment A

Scope of Work/Services Required:

Armored Car (Agent) will pick up from the Franklin County Treasurers office daily, Monday through Friday. The agent will arrive at the counter, at that time a member of the office will bring the agent deposit bags along with a log that tracks all the deposit bags that are being picked up. The agent will sign off on the log and will scan the bags as picked up. The bags will be delivered same day to the local Umpqua branch in Pasco on 20th Ave.

The County will also occasionally receive change orders from the bank. This usually occurs once a week but can happen multiple times a week. When a change order is available to be delivered to the County, the bank will notify the armored car driver at the time of the deposit drop off. The armored car will then take the change order and deliver it to the County the next business days while picking up days deposits.
