This vehicle was a surplus from the Sheriff's Office a number of years ago. This vehicle has been reliable until the past year or so. It is approximately 14 years old and is becoming very un-reliable and has broken down multiple times recently. This vehicle is driven to very remote locations (tower sites) and often there is no radio and/or cell phone coverage and I am getting increasingly concerned for staff safety. We desire to purchase a new 2020 Ford F150 pickup truck from Columbia Ford in Longview Washington including a canopy w/Side Door Access Tool Storage Boxes. Also included is a "Cargo Glide XL, slide out truck bed tray. This purchase is from WA State contract #05916. Per terms of the contract, free delivery to our address is provided.
