## AUTHORIZATION TO APPROVE FUNDS TO REPLACE DOOR LOCKS IN THE FRANKLIN COUNTY CORRECTIONS CENTER

WHEREAS, pursuant to RCW 36.01.010 and RCW 36.32.120 the legislative authority of each county is authorized to enter into contracts on behalf of the county and ensure the care of county property and management of county funds and business; and

WHEREAS, the Franklin County Sheriff's Office operates the Franklin County Corrections Center (Jail): and

WHEREAS, the doors in the Jail's Hub, which consist of Pods M, N, O, P, Q, and R, are requiring replacement: and

WHEREAS, Franklin County finds that the ability to properly secure inmates and protect corrections officers cannot reasonably be done without replacing the current locks; and

WHEREAS, Franklin County finds that the current locks are sufficiently dangerous as to constitute an immediate and on-going concern and must be addressed as soon as possible; and

WHEREAS, Franklin County received two bids for this specialized work to be performed, and accepts Willo Products Company Inc.'s bid in the amount totaling \$235,143.00; and

**NOW, THEREFORE, BE IT RESOLVED** that Franklin County agrees to set up a fund of \$235,143.00 to replace the locks in Pods M, N, O, P, Q, and R, as approved by the Board.
