BACKGROUND: The 2011 Ford F150, ID #LT-8412, VIN #1FTFX1EF2BFB05373, 1970 Propane Trailer, ID #TR-1444, No VIN, 2002 Crack Sealer, ID #WE-2013, VIN #2230211, 2000 Swenson Sander, ID #WY-2862 Model Number #EV-100-14-54, 1972 Meyers Sand Spreader, ID #WY-2762 Model UGT-600, No VIN, and the following Miscellaneous Items: 27-Broom Cores, 1 - Northend Truck Dump Box, 1 - Snyder Sprayer Tractor Mount, were purchased through the Motor Vehicle Fund, which is part of the County's equipment rental and revolving fund, enshrined in Chapter 36.33A RCW. These vehicles have reached the end of their useful service life.

The vehicles are and have been determined that they can be declared surplus – the funds recovered from the sale becoming part of the Motor Vehicle Fund, per 36.33A.050 RCW. This sale and its conditions would be overseen by the Public Works Director – per 36.33A.030 RCW – upon authorization from the Board. Upon declaring the vehicles surplus and selling at public auction, the vehicles will be removed from the Motor Vehicle Fund records by the County Auditor.

The Chairman of the Board may sign the titles for the Motor Vehicle (ER&R) Fund vehicles, releasing Franklin County's interest in said vehicles.

NOW, THEREFORE, BE IT RESOLVED that the Board of Franklin County Commissioners declare the subject county property as surplus, and authorize the Public Works Director to dispose of the property via Public Auction, and to therefore have the County Auditor remove the property, as may be applicable, from the inventory list for the Motor Vehicle (ER&R) Fund, and County Sheriff Fund; and
