SUBJECT / ISSUE: Supplement Election Reserve Fund Budget due to receipt of HAVA Grants

FISCAL IMPACT: \$299,302.07 (Rounded to \$299,303)

BACKGROUND: Franklin County was successful in obtaining two federal pass through grants through the WA ST Office of the Secretary of State. The two grants are both part of the Help America Vote Act (HAVA):

- \$165,736.72 for the purpose to "prevent, prepare for, and respond to coronavirus, domestically or internationally, for the 2020 Federal election cycle."
- \$133,565.35 for the purpose to "improve the administration of elections for Federal office, including to enhance election technology and make election security improvements" to the systems, equipment and processes used in federal elections.

Franklin County has already received these funds, but the Election Reserve Fund budget does not have the capacity to make these expenditures, therefore it needs to be supplemented \$299,302.07.

RECOMMENDATION: Adopt Attached Resolution increasing the bottom lines of the Franklin County Election Revolving Fund budget From \$280,000 to \$579,303.
