SUBJECT: Petition for vacating right of way dedicated for future W. Dradie Street				

FISCAL IMPACT: Chapter 12.08 of the Franklin County Code would govern this vacation. All costs incurred in the investigation would be at the expense of the petitioners including time spent in the examination and reporting and all advertising costs. Pursuant to Chapter 12.08 reimbursements are paid into the County Road fund.

ACTION(S) REQUESTED: Pursuant to Chapter 12.08.020 of the Franklin County Code; upon the filing of such a petition the Board of County Commissioners may, but is not required to, proceed with an intention to vacate the portion of right of way for future W. Dradie Street as requested in the petition. The Board will need to decide if they are going to consider the petition or not.

If the Board decides to consider the petition it must signify its intent with a resolution and order the County Engineer to report on such vacation. A resolution has been prepared for the Board's use if this course of action is desired.

RECOMMENDATION:

Staff recommends that the Board consider the petition for the vacation of right of way dedicated for future W. Dradie Street.

SUGGESTED MOTION: I hereby move that the Board of Franklin County Commissioners approve the resolution ordering the county engineer report on the possible vacation of right of way dedicated for future W. Dradie Street, so that board may consider the usefulness of such right of way.

WHEREAS, a public hearing will be scheduled, at a future date, and advertised as required by law upon the completion of the report by the county road engineer in order to consider said report together with any other evidence for or against such proposed vacation; and

WHEREAS, pursuant to Franklin County Code Chapter 12.08.060 all cost and expenses incurred in the examination and report on the petition shall be paid by the petitioners and the county engineer shall include their bill for such examination as part of their report;

NOW, THEREFORE, BE IT RESOLVED that the Franklin County Board of Commissioners, hereby orders the county road engineer to report on the possible vacation of the right of way dedicated for future W. Dradie Street so that the Board may consider the usefulness of such road.







