FISCAL IMPACT:			
PSC was awarded the construction contract for \$55,440; final cost of the contract is \$56,026.83.			
FHWA Highway – Safety Improvement Program (HSIP) grant funds committed \$114,000 for the construction phase of this project including staff's time. This phase is 100% funded with grant funds. Any non-eligible expenditures were funded through 595.12 – Construction Engineering.			
BACKGROUND:  On September 3 <sup>rd</sup> , 2019, the Board of County Commissioners executed a contract for CRP 618 – Safety – Rumble Strips with Construction Ahead dba Pavement Surface Control (PSC) for \$55,440 (Resolution 2019-278). The contract was for the installation of shoulder and centerline rumble strips along Glade North Road from Pasco City limits to Selph Landing Road and along Pasco-Kahlotus Road from Pasco City Limits for approximately one mile in order to reduce roadway departure accidents.			
On June 29th, PSC physically completed the project for the total of \$56,026.83.			
Section 1-05.12 of the Contract Specifications states that once the Contractor has performed all the obligations under the contract a completion date and final acceptance will be established.			
Franklin County Public Works has received all necessary documentation and releases to close out the contract.
