SUBJECT / ISSUE: Interlocal Agreement for prosecution of Franklin County criminal case in Benton County Veterans Court

FISCAL IMPACT: \$10,000 (paid up front, but covers an 18 month term) - Full amount is within Prosecutor's 2021 budget.

BACKGROUND: Benton County runs a therapeutic Veterans Court program for local Veterans as an alternative route through the criminal justice system for those charged with crimes who are mentally ill or who have co-occurring mental health and substance abuse disorders. Franklin County is currently prosecuting J.G., a Veteran, who would benefit from being involved in the program. Franklin County does not currently operate a Veterans Court. Benton County has agreed to accept J.G. into their program for a fee of \$10,000 which is to cover the 18 month program. If the defendant drops out or is terminated from the program before completion, Benton County will return a prorated fee equal to the number of remaining months.

APPROVING INTERLOCAL AGREEMENT FOR PROSECUTION OF FRANKLIN COUNTY CASE IN BENTON COUNTY VETERANS COURT

NOW, THEREFORE, BE IT RESOLVED the Franklin County Board of Commissioners hereby approves the Interlocal Agreement, with Benton County for the prosecution of a Franklin County criminal case in Benton County Veterans Court.

INTERLOCAL AGREEMENT FOR PROSECUTION OF FRANKLIN COUNTY CASE IN BENTON COUNTY VETERANS COURT

This 2021 Interlocal Agreement ("Agreement") for prosecution of a Franklin County case in Benton County Veterans Court is entered into by and between the County of FRANKLIN and the County of BENTON pursuant to the Interlocal Cooperation Act, Chapter 39.34 RCW.

WHEREAS, Chapter 39.34, RCW permits local government units to make the most efficient use of their powers by enabling them to cooperate with other localities and thereby to provide services and facilities in a manner that will accord best with geographic, economic, population, and other factors influencing the needs and development of local communities; and

WHEREAS, Benton County has determined to create and operate a veterans court for the purpose of providing an alternative route through the criminal justice system for veterans charged with crimes who are mentally ill or who have co-occurring mental health and substance abuse disorders by entering them into the specialized Veterans Court program; and

WHEREAS, Franklin County does not currently have a Veterans Court Program but currently has a veteran Defendant identified as J.G.; and

WHEREAS, Both the Defendant and the community would benefit from the services offered by the Benton County Veterans Court; and

WHEREAS judicial economy is best served by authorizing the designated prosecutor from the Benton County Prosecuting Attorney's Office to handle the prosecution of "Defendant" in Benton County veteran's court; and

WHEREAS, Franklin County shall pay Benton County the amount of \$10,000 (ten thousand dollars).

NOW, THEREFORE, in consideration of the mutual covenants contained herein, and upon approval in accordance with RCW 39.34, the parties do hereby agree as follows:

I. TERMS OF AGREEMENT

- 1. Duration: This agreement is for the entry of a single Franklin County Defendant in Benton County Veterans Treatment court, the duration of which shall not exceed 18 months from J.G's entry into the program.
- 2. Termination: This agreement is terminated only upon graduation or revocation of Defendant from the program.

3. Payment: Franklin County shall pay Benton County the amount of \$10,000 (ten thousand dollars) for 18 months of service upon acceptance and entry of J.G. into the Veterans Court Program. If Defendant is revoked from the program prior to completion, Franklin County shall be reimbursed a pro-rated amount equal to the remaining number of months.
