Re-Appointment of C. Lester Domingos to Represent Franklin County on the Board of Commissioners of the Housing Authority of the City of Pasco and Franklin County for a Five-Year Term that Expires January 28, 2027.

WHEREAS, in August 2016, the Franklin County Commissioners appointed Caetone Lester Domingos to fulfill an unexpired term on the Housing Authority's Board of Commissioners left vacant by the resignation of Dori Clark; and,

WHEREAS, the term expired January 28, 2017, and Mr. Domingos has expressed a willingness to continue to serve on the Housing Authority's Board of Commissioners; and,

WHEREAS, Mr. Domingos term is expired on January 28, 2022 and has expressed his willingness to continue to serve on the Housing Authority's Board of Commissioners; and,

WHEREAS, Mr. Domingos has a great interest and concern for the low-income population of Pasco and Franklin County and is a tireless advocate for affordable housing in the community; and,

WHEREAS, the Board of Franklin County Commissioners constitutes the legislative authority for Franklin County and feels it is in the best interest of Franklin County to re-appoint Mr. Domingos to the Housing Authority's Board of Commissioners.

NOW, THEREFORE, BE IT RESOLVED The Franklin County Board of Commissioner hereby approves the re-appointment of Caetone Lester Domingos to serve as a Franklin County representative on the Board of Commissioners for the Housing Authority of the City of Pasco and Franklin County for a five-year term that will expire on January 28, 2027.
