- Steve Bauman asked why there are so many Executive Sessions. The public needs to know what the topics are after the secrecy ends. He would like to see a specific title given to executive session, not just the legal description of potential litigation.
- Mr. Johnson explained the purpose of Executive Sessions, and why the information is excluded from the public during this time.
- Lupe Cardenas is a member of the redistricting committee. He explained the process of how the committee came up with the maps presented today and he hoped that this would help with moving forward.
