Tri-Cities Chaplaincy DBA Chaplaincy Health Care has been providing counseling and consultation services to the Juvenile Detention facility since 2002. Chaplaincy Health Care provides individual and group care counseling services for youth in detention. Chaplaincy Health Care responds to clergy who have parishioners at the Juvenile Detention facility or who have questions about the facility's services.

PROFESSIONAL SERVICES CONTRACT AMENDMENT NO. 1

This Contract Amendment No. 1 is made and entered into by and between Benton County, a political subdivision, with its principal offices at 620 Market Street, Prosser, WA 99350 and Franklin County, a political subdivision, with its principal offices at 1016 North Fourth Avenue, Pasco, WA 99301, by and for the Benton-Franklin Counties Juvenile Justice Center, a bi-county agency located at 5606 W. Canal Place STE 106, Kennewick, WA 99336 (hereinafter collectively referred to as "Counties"), and **Tri-Cities Chaplaincy DBA Chaplaincy Health Care**, 1480 Fowler Street, Richland, WA 99352 (hereinafter referred to as "CONTRACTOR").

In consideration of the mutual benefits and covenants contained herein and in the parties' contract, numbered as Benton County Resolution No. 2022 035 and executed on January 11, 2022 and Franklin County Resolution No. 2021 288 and executed on December 14, 2021 (the "Contract"), the parties agree to amend the Contract as follows:




