9:20 a.m. Update on RFP for Behavioral Health Provider for Crisis Recovery Center

Benton County Commissioner Jerome Delvin and Human Services Director Kyle Sullivan addressed the Board with an update on the crisis recovery center. Benton County Deputy Administrator Matt Rasmussen has distributed an RFP (request for proposal) to providers that would be interested in running the crisis recovery center. Commissioner Delvin was hopeful in securing a provider soon, as he would like them to assist in design and construction of the facility. Benton County would be the contract holder with the provider to keep it simple.

- ❖ *After the discussion, the Franklin County Commissioners were in consensus to set up the crisis center program similar to the MOU (memorandum of understanding) that currently runs the Human Services Department.*

9:48 a.m. Office of Public Defense Presentation

Office of Public Defense Manager Larry Zeigler gave an update on his office situation. He is having a hard time obtaining and maintaining attorneys, due to the scope, salary and availability of qualified attorneys. Chief Civil Attorney Jennifer Johnson suggested hiring attorneys as full time employees with benefits. An additional concern is the availability to find office space to accommodate new employees.

10:07 a.m. Step Exception for Auditor's Office Employment Office

Thomas Westerman and Tim Anderson presented the Board with a request for a step exception in order to fill a position in the auditor's office. This position has been available since May and qualified applicants are difficult to find. The current applicant was a previous employee and has knowledge with the system.

- ❖ *After discussion, Commissioner Mullen moved to approve resolution 2022-198 (step exception). Commissioner Peck seconded and the motion carried.*

10:16 a.m. County Business Vehicle Policy (Returned-Revised)

Administrator Keith Johnson held a discussion with additional input from the department head and elected.

Assessor John Rosenau listed a few of his concerns with the policy. Some items were not clear on usage as it pertains to personal vehicles. Other policies were too restrictive, such as preapproval from the Commissioners and Administrator before loaning out vehicles to other departments when they are in need of transportation to conduct county business.

He let the Board know that he was in need of transportation to and from his home to the courthouse for work for a brief time. He recorded his mileage and submitted funds as a reimbursement for usage of the county vehicle during that time.

Auditor Matt Beaton stated that there are many personal vehicles used during elections while collecting ballots from boxes around the county. He mentioned that the Elections Office is looking into purchasing a county vehicle so that employees would not need to use their own for county business. He supports a policy like this; however, he believed language could be clearer.

Sheriff Jim Raymond suggested having pool cars available for county business.

Coroner Curtis McGary, Assessor John Rosenau and Auditor Matt agreed that having pool cars would be beneficial to the county.

Administrator Keith Johnson would review this policy and address changes as needed.

10:30 a.m. PUBLIC HEARING Declaring Real Property as Surplus- Wilson House

Commissioner Didier opened the public hearing at 10:31 a.m.

Administrator Keith Johnson explained the background process of declaring the “Wilson House” as surplus and placing it up for auction. A public hearing is an essential formality, required by state law in declaring surplus property.

After a brief discussion, Commissioner Didier closed the public hearing at 10:32 a.m.

- ❖ *Commissioner Peck moved to approve resolution 2022-200 as presented. Commissioner Mullen seconded and the motion carried.*

Administrator Keith Johnson heard back from the State Auditor’s Office regarding some questions around the Prosecuting Attorney’s vehicle use and reimbursement for mileage. When Mr. Sant became aware of the situation, he remitted an overpayment of funds back to the county and the State Auditor’s Office was satisfied with that result.

10:34 a.m. Public Comment

- George Dockstader suggested the Commissioners look twenty years down the road as to what is needed for the future growth of Franklin County, rather than just a year ahead.
- Assessor John Rosenau mentioned we are behind ten years in space for employees. The rate of growth is not going to slow down and he urged the Commissioners to allow the County Administrator to look at plans for expansion and growth development with county facilities and staffing.
- Sheriff Jim Raymond suggested acquiring property around the courthouse.
- Commissioner Mullen informed the public that the Ben Franklin Transit would be shuttling people to and from the fair this year.

10:40 a.m. Executive Session RCW 42.30.110(1) (g) – *evaluate the qualifications of applicant for employment or review performance of public employee.*

Commissioner Didier recessed into Executive Session at 10:40 a.m., for up to 15 minutes to discuss litigation. Those participating are Commissioner Didier, Commissioner Mullen, Commissioner Peck, and County Administrator Keith Johnson.

10:55 a.m. Commissioner Didier reconvened the regular meeting.

Commissioner Didier asked Mr. Johnson if he is currently looking into acquiring properties close to the courthouse. Mr. Johnson has not been able to connect with the owners of property north of the courthouse; however, he was able to speak with Bob Thompson who has a building south of the courthouse, as well as the US Bank in downtown Pasco.
