PROFESSIONAL SERVICES CONTRACT AMENDMENT NO. 1

This Contract Amendment No. 1 is made and entered into by and between Benton County, a political subdivision, with its principal offices at 620 Market Street, Prosser, WA 99350 and Franklin County, a political subdivision, with its principal offices at 1016 North Fourth Avenue, Pasco, WA 99301, by and for the Benton-Franklin Counties Juvenile Justice Center, a bi-county agency located at 5606 W. Canal Place STE 106, Kennewick, WA 99336 (hereinafter collectively referred to as "Counties"), and Calvert Technical Services, Inc., PO Box 1210, 25509 Calvert Drive N, Davenport, WA 99122 (hereinafter referred to as "CONTRACTOR").

In consideration of the mutual benefits and covenants contained herein and in the parties' contract, numbered as Benton County Resolution No. 2022 302 and executed on May 3, 2022 and Franklin County Resolution No. 2022 087 and executed on April 26, 2022 (the "Contract"), the parties agree to amend the Contract as follows:

1. Section 10 of the Contract ("Performance and Payment Bonds") shall be amended in its entirety and shall read:

The CONTRACTOR shall furnish the COUNTIES with a Performance Bond and Labor and Materials Payment Bond with sufficient sureties acceptable to the COUNTIES, in an amount equal to one hundred percent (100%) of the contract sum as security for the performance by the Contractor of this Contract and payment of all the persons performing labor and supplying materials pursuant to this Contract. PROVIDED that the CONTRACTOR may elect, in lieu of the bonds, to allow the COUNTIES to retain ten percent (10%) of the contract amount for a period of thirty (30) days after the date of final acceptance. Proof of the performance and payment bonds, or written notification of the CONTRACTOR'S desire to elect the alternative to the bonds (described above), must be received by COUNTIES within ten (10) days following the execution of this Contract.

Except as expressly provided in this Contract Amendment No. 1, all other terms and conditions of the original Contract shall remain in full force and effect.

This Amendment shall be effective on the last date signed and shall expire June 30, 2023.
