This Contract is set to expire on November 7, 2022. \$250,000.00 additional dollars are required in order to meet the demands for required staffing and medical/mental health care.

WHEREAS, both parties wish to amend the Personal Services Contract to provide inmate medical services to inmates in custody within the Franklin County Corrections Center, and

WHEREAS, pursuant to RCW 36.01.010 and RCW 36.32.120 the legislative authority of each county is authorized to enter into contracts on behalf of the county and ensure the care of county property and management of county funds and business; and

WHEREAS, the Board of Franklin County Commissioners constitutes the legislative authority of Franklin County and desires to amend the Personal Services Contract, which was originally approved March 2, 2021, Franklin County Resolution No. 2021-048, and it being in the best interest of Franklin County; and

WHEREAS, the current contract is set to expire on November 07, 2022, and the Amendment shall extend the Personal Services Contract from November 08, 2022 through December 31, 2026; and

NOW, THEREFORE, BE IT RESOLVED the Franklin County Board of Commissioners hereby approves the Amendment to the Personal Services Contract between Franklin County and R & B Fleck Enterprises dba Western Medical Resources, LLC as written, and remaining language within the Contract not affected by the Amendment.

FIRST AGREEMENT AMENDMENT TO THE PERSONAL SERVICES CONTRACT BETWEEN WESTERN MEDICAL RESOURCES AND FRANKLIN COUNTY

This Agreement Amendment, made and entered into this 25th day of October, 2022 by and between R & B Fleck Enterprises dba Western Medical Resources, LLC (Contractor) and Franklin County, WA. (County)

WHEREAS, per County Resolution 2021-048, County and Contractor entered into a contract and the Contractor shall provide inmate medical, Mental Health, and Medication Assisted Treatment services to inmates within the Franklin County Corrections Center.

WHEREAS, the purpose of this Amendment is County and Contractor have agreed to extend the current Contract terms and conditions for an additional four (4) 12-month periods from November 8, 2022 through December 31, 2026, and increase compensation; and

NOW, THEREFORE in consideration of the provisions and agreements set forth herein, the parties agree that all provisions of their original Contract shall remain in effect except for the below: Section- Duration of Contract, Section- Compensation, Section – Franklin County Corrections Facility Fee Schedule, which language shall be replaced in its entirety as written in the following:

1. Duration of Contract:

The term of this Contract shall begin November 8, 2022, and shall expire on December 31, 2026 unless terminated sooner as set forth herein. The term of this Contract shall automatically extend an additional two years at the end of the first term unless the COUNTY notifies the CONTRACTOR in writing at least 60 days prior to the original termination date that they do not wish the contract to be extended. The CONTRACTOR shall complete all work by the time(s) specified herein, or if no such time is otherwise specified, within a reasonable time no later than the expiration date.

2. Compensation:

For the services performed hereunder, the CONTRACTOR shall be paid according the fee schedule which is attached:

a. The COUNTY shall compensate the CONTRACTOR in the amount of approximately one hundred sixty thousand three hundred ninety-seven dollars and 66 cents per month (\$160,397.66/month) for services rendered pursuant to the enclosed Fee Schedule. Charges for premium nurse and provider call out will be billed to the COUNTY on a monthly basis if/as incurred. The COUNTY shall compensate the CONTRACTOR in the amount of \$28,185.00/month for services provided under the MAT Program.

- b. No payment shall be made for any work performed by the CONTRACTOR, except for work identified and set forth in this Contract.
- c. The CONTRACTOR shall submit invoices to the COUNTY not more than once per month during the progress of the work for partial payment of the work completed to date. Invoices shall cover the time CONTRACTOR performed work for the COUNTY during the billing period. The COUNTY shall pay the CONTRACTOR for services rendered in the month following the actual delivery of work and will remit payment within thirty (30) days from the date of receipt.
- d. The CONTRACTOR shall not be paid for services rendered under this Contract unless and until they have been performed to the satisfaction of the COUNTY.
- e. In the event the CONTRACTOR has failed to perform any substantial obligation to be performed by the CONTRACTOR under this Contract and such failure has not been cured within ten (10) days following notice from the COUNTY, the COUNTY may, in its sole discretion, upon written notice to the CONTRACTOR, withhold any and all monies due and payable to the CONTRACTOR, without penalty, until such failure to perform is cured or otherwise adjudicated. "Substantial" for the purposes of this Contract means faithfully fulfilling the terms of this Contract with variances only for technical or minor omissions or defects.
- f. Unless otherwise provided in this Contract or any exhibits or attachments hereto, the CONTRACTOR will not be paid for any billings or invoices presented for services rendered prior to the execution of this Contract or after its termination.
- g. The parties agree the County will handle processing of co-pays charged to offenders for medical and mental health services.
