SUBJECT: COLUMBIA BASIN VETERANS ASSEMBLY PARKING LOT RECONSTRUCTION AWARD LETTER – SMALL WORKS ROSTER								
FISCAL IMPACT: This parking lot reconstruction project is reimbursable work handled through the office of the County Administrator.								
BACKGROUND:								
Franklin County Public Works has been tasked with overseeing the bidding, and project management for the reconstruction of the Columbia Basin Veterans Assembly Parking Lot Reconstruction project. The existing parking lot for this County owned facility has surpassed its design life expectancy. It has been requested by the County Administrator to reconstruct the parking lot, to current construction specifications.								
The amount estimated to complete this project meet the requirements for award as a small works contract in accordance with RCW 39.04.155.								
In accordance with Franklin County purchasing policy (Resolution 2017-191), the Public Works Department contacted vendors registered on the MRSC small works roster for agencies within Washington State via email in order to obtain bids for the reconstruction of the Veterans Parking Lot. Over one hundred (100) vendors (more than the five vendors required for the small works process) were contacted. Of all the vendors contacted, eight (8) returned bids, which are summarized in the attached bid tab summary.								
The bidders were all supplied the same specifications and estimated quantities. Work is expected to begin and be completed in the Fall of 2022, or early Spring of 2023.								
The lowest bid obtained was from ESF Solutions LLC, of Walla Walla, Washington, for the total bid amount of \$78,031.00, sales tax included for all bid item(s).								
RECOMMENDATION: Staff recommends the Franklin County Board of Commissioners award the contract to ESF Solutions LLC. SUGGESTED MOTION: I hereby move to approve the award letter for the Columbia Basin Veterans Assembly Parking Lot Reconstruction Project to ESF Solutions LLC of Walla Walla, Washington.
