BACKGROUND: The Assessor's office currently has budgeted \$42,000 in the 2022 ARP Budget for the purchase of a vehicle and was approved to purchase in April of 2022 by the BOCC a 2022 Ford Explorer, This vehicle was ordered and Ford has advised that the order cannot be filled by a 2022 unit.

RE: PURCHASE OF ASSESSOR'S OFFICE DEPARTMENT VEHICLE FROM 2022 ARP BUDGET 119

WHEREAS, the BOCC approved in April of 2022 the purchase of a 2022 Ford Explorer from Corwin Ford for the County Assessor's Office from ARP funds in the amount of \$42,000 and

WHEREAS, Corwin Ford has advised that Ford will not be able to complete the order for the 2022 Ford Explorer and

WHEREAS, Corwin Ford has advised that the vehicle ordered has been moved to a 2023 Ford Explorer with a build date in January of 2023

WHEREAS, there are funds in the 2022 budget in the American Rescue Plan funds for an Assessor's Office vehicle purchase of up to \$42,000 and the 2023 Ford Explorer with equipment will still come in at or below the \$42,000.

NOW THEREFORE BE IT RESOLVED that the Board of Commissioners hereby approve the change from a 2022 Ford Explorer to a 2023 Ford Explorer 4dr 4x4 vehicle from Corwin Ford for the Assessor's Office in the amount not to exceed \$42,000.00 to include tax, lic and equipment from the previously approved funds:
