**IN THE MATTER AMENDING A PROFESSIONALS SERVICES AGREEMENT WITH
ATTORNEY KARYN OLDFIELD TO PROVIDE PUBLIC DEFENSE SERVICES IN
FRANKLIN COUNTY JUVENILE COURT**

WHEREAS, Franklin County is obligated by law to provide indigent defense services in Franklin County Superior and District Courts, and

WHEREAS, Franklin County entered into a Professional Services Agreement with Karyn Oldfield per Resolution 2022-040 on or about the date of March 1, 2022, and

THEREFORE BE IT RESOLVED, which said contracts with Karyn Oldfield and Franklin County is hereby amended as follows to wit:

Resolution: 2022-040 PARAGRAPH 1 shall be amended from "*AGREEMENT TERM. This Agreement shall be deemed effective for all purposes as of January 01, 2022, and shall continue thereafter through and including December 31, 2023, unless earlier terminated pursuant to the applicable terms and provisions of this Agreement.*" and shall be now further changed to a term date through December 31, 2024.

PARAGRAPH 12 shall be amended from "*As compensation for Attorney's performance and rendering of independent professional legal services under the Agreement, the County shall pay Attorney, as professional service attorney fees and not as employment salary/wages, the sum for the following: 2022: \$91, 173.86, 2023: \$93,909.08*" and shall now be further changed to annual compensation in the amount of \$98,000 for 2023 and \$100,000 for 2024, paid in equal monthly installments in each respective year.
