Mrs. Moreno has informed us that she has signed a contract with OCLA, which requires any attorney holding a full OCLA children's representative contract to not have another contract. On December 1, 2022, the Juvenile Justice Center received an email notification from Mrs. Moreno of her notice of intent to terminate her Personal Services Contract effective December 31, 2022.

In accordance with Section 8(a) of the Contract, the Benton-Franklin Counties Juvenile Justice Center, in mutual agreement with Kathleen Moreno, have elected to terminate Personal Services Contract on December 31, 2022.
