WHEREAS, RCW 36.35.120 authorizes the Board of County Commissioners to dispose of tax title property when it appears to the Board that it is in the county's best interests; and

WHEREAS, RCW 36.35.150 allows the Board of County Commissioners to dispose of tax title property by private negotiation without a call for bids, when the county legislative authority determines that it is not practical to build on the property due to physical characteristics of the property;

WHEREAS, Franklin County Parcel Nos. 109862446, 112096054, 112105114, 113310382, 113771027, 113813017, 123472162, 123473134, 123473287, and 123690140 was acquired by Franklin County by virtue of a tax foreclosure auction at which no offer to purchase the property was received, and

WHEREAS, RCW 36.35.120 provides that publication of notice of intent to sell property is not required when the property is to be sold by private negotiation, now therefore
