#### **BACKGROUND:**

The Disability Board, governing the medical reimbursements for the LEOFF I retirees, has experienced an abnormally high monthly reimbursement for one of the retirees. Though the budgeting process for 2023 fell under normal processing history, this year has an unexpected increase of reimbursements for long-term care and the budget cannot support the current need of reimbursements.
