FISCAL IMPACT: There are currently unfilled vacancies for felony defenders positions. Due to the number of vacancies, we are unlikely to exceed current 2023 budget. We are also seeking to use ARPA funding under appropriate circumstances minimizing impact upon county budget for 2023.				
BACKGROUND: OPD is faced with a crisis regarding the staffing of defenders. Currently we are down several attorneys. The manager needs authority to hire qualified candidates and offer salaries appropriate to said qualified candidates, without prior approval from the Board of Commissioners. This will allow extending a job offer to qualified attorneys at the appropriate steps within grade 20 and 21 as determined by the OPD manager. This will ensure certainty among potential candidates to accept a contract of an offer of employment from Franklin County without risk of their being lost to other employers.
