SUBJECT: Resolution Accepting the Work Performed by Frank Gurney, Inc of Spokane Valley, Washington for County Road Maintenance Project (CRMP) 2020-002-Burr Canyon Guardrail Replacement.	
FISCAL IMPACT: Frank Gurney, Inc was awarded the contract for \$681,303.00; final cost of the contract is \$688,660.50. Federal Emergency Management Agency (FEMA) and Washington State Military Department obligated \$1,031,226.25 towards CRMP 2020-002 Burr Canyon Guardrail Replacement project. Franklin County Public Works cost share is 5% of the eligible non-federal share.	
BACKGROUND: On February 22 nd , 2023, Franklin County executed a contract for the above-mentioned construction project to Frank Gurney, Inc for \$681,303.00 excluding sales tax (Resolution 2023-073). The contract's scope of work was to replace 13,510 LF of guardrail and end terminals that were destroyed or compromised during the Wildfire's Disaster No. 4584-DR-WA. On June 12 th , 2023, Frank Gurney, Inc physically completed the project for the total cost of \$688,660.52. There was neither change orders nor force accounts for this project. Section 1-05.12 of the Contract Specifications states that once the Contractor has performed all the obligations under the contract a completion date and final acceptance will be established. Franklin County Public Works has received all necessary documentation and releases to close out the contract.
