***AUTHORIZING OF A DECLARATION OF SURPLUS EQUIPMENT AND SALE OF SURPLUS
EQUIPMENT AT PUBLIC AUCTION***

WHEREAS, the Board of Franklin County Commissioners constitutes the legislative authority of Franklin County and finds the surplus of the following list of items as being in the best interest of Franklin County to sell;

WHEREAS,. These items are 2 Commercial refrigerators, carpet cleaner; ARC welder with cart; Walk behind floor cleaner; four (4) turnstiles; two (2) ATM machines; three (3) vacuums; four (4) ticketing machines; six (6) porta cools; Husqvarna parted mower; ride on floor cleaner; two (2) racks of 5x5 metal flooring with edges; four (4) carts with 10 table rounds each.

WHEREAS, The Facilities Director and HWL Group have determined the equipment, listed above, to have reached the end of their useful life for county purposes, and that the sale of said equipment, through public auction, to be the most cost effective for the county.




