
WHEREAS, Abadan requests that we include additional language that was missing from the original quote and initial next to the additional text block accepting the additional text; and

WHEREAS, HAPO Center is requesting authorization to lease a copier for the admin office; and




WHEREAS, The Fiscal impact is \$116.26 per month to be paid by HAPO Center; and


