WHEREAS, A recent copier purchase for the Assessors' office was approved with quotes that were missing language required for the vendor's records; and



WHEREAS, Abadan requests that we include additional language that was missing from the original quote and initial next to the additional text block accepting the additional text; and



WHEREAS, the Assessors Office is in need of initiating a new lease under a new resolution; and






