**2025 BUDGET TRANSFERS FOR PUBLIC SAFETY BUILDING  
SECURITY AND CORRECTIONS DEPARTMENT UNIFORMS**

**WHEREAS**, the Board of Franklin County Commissioners constitutes the legislative authority for Franklin County; and

**WHEREAS**, Resolution 2025-0131 clarified that the security and control of the Public Safety Building (PSB), including the guard shack and parking lots, shall fall within the exclusive discretion of and control of the Board of County Commissioners; and

**WHEREAS**, the Board of County Commissioners entered into a contract with Tri-Cities Monitoring to “Perform security services to maintain a safe environment for the Franklin County Courthouse, Public Safety Building, and Justice Center staff, clients, and the public under the direction of the County Administrator” and “Assist with screening activities in the Security Building when necessary and perform pat-down searches of persons entering the Franklin County Courthouse campus area, as necessary to prevent weapons being brought into the facility”; and

**WHEREAS**, currently the entire 101580-Security budget is \$5,000 as previously security services in the guard shack were performed by Corrections employees and paid out of the Corrections budget and thus budget is needed for this new contract with Tri-Cities Monitoring; and


**WHEREAS**, Resolution 2025-0132 transferred operation of the Franklin County Jail and its staff from the Franklin County Sheriff to the Board of County Commissioners and created a Franklin County Department of Corrections; and

**WHEREAS**, the uniform budget for both the Sheriff’s Office and Corrections has been budgeted and paid out of the Sheriff’s Office since 2022 and budget is needed in the newly established Correction Department;

**NOW, THEREFORE, BE IT RESOLVED** that the Franklin County Board of Commissioners approves a transfer of \$200,000 to 101540 – Corrections, objects 1000-Salaries and Wages \$130,721; 2010-Social Security/Medicare \$10,430; 2020-Medical & Dental \$32,717; 2030-Retirement \$12,859; 2040-Industrial Insurance \$12,918; and 2055-Paid FMLA \$355 to 101580 - Security, object 4128 – Contracted Security Services and a transfer of \$37,531 from 101520 – Sheriff, object 2070-Uniforms to 101540 – Corrections, object 2070-Uniforms
