The Honorable Board of Franklin County Commissioners met on the above date. Present for the meeting were Neva J. Corkrum, Chairman; Bob Koch, Chair Pro Tem; and Frank H. Brock, Member; Fred Bowen, County Administrator; and Mary Withers, Clerk to the Board.

**OFFICE BUSINESS**

Secretary Patricia Shults met with the Board.

Consent Agenda

**Motion** - Mr. Brock: I move for approval of the consent agenda as follows:

1. Approval to designate each Board member to act on the Franklin County Canvassing Board held throughout the year 2006 in the following available order: Neva J. Corkrum, Chairman; Robert E. Koch, Chair Pro Tem; and Frank H. Brock, Member. (Exhibit 1)
2. Approval of **Resolution 2006-023** for an intra budget transfer in the amount of \$163 within the **2005** Current Expense Auditor Budget, #001-000-060, from line item 514.10.10.0050 (Accounting Assistant) to line item 514.10.31.0001 (Supplies – Non Dept Data Processing). (Exhibit 2)

Overtime in Dispatch

The Dispatch overtime budget was overspent in 2005 by \$31,000. Mrs. Corkrum feels the Dispatch Department should be letting the Board know before the eleventh hour

because they know what their overtime is. There was \$4000 overspent in overtime in the Jail kitchen.

Vouchers/Warrants

**Motion** – Mr. Koch: I move for approval of the following payroll vouchers/warrants: Salary Clearing Payroll warrants 39199 through 39296 for \$148,133.27; warrants 39297 through 39301 for \$44,203.51; and Direct Deposit for \$217,905.13; for a total amount of \$410,241.91. Second by Mr. Brock. 3:0 vote in favor.

**PLANNING AND DEVELOPMENT DEPARTMENT**

Planning Director Jerrod MacPherson and Assistant Director Greg Wendt met with the Board.

Public Hearing: Short Plat SP 2005-15 for applicant Ray Carlisle to short plat 3.34 acres into four lots. The lots are each approximately 1/2 acre in size with the exception of the existing home-site which is proposed to be 1.68 acres in size. The property is zoned Residential Suburban 20,000 (RS-20).

Public Hearing convened at 9:17 a.m. Present: Commissioners Corkrum, Koch and Brock; County Administrator Fred Bowen; Planning Director Jerrod MacPherson; Assistant Director Greg Wendt; and Clerk to the Board Mary Withers. Present in audience: Ray Carlisle and Richard A. Rogers.

Mr. Wendt reviewed the information on the Action Summary (Exhibit 7).

Mr. MacPherson showed a copy of the plat as submitted by the applicant. He reviewed the conditions of approval.

Mrs. Corkrum asked three times if anyone in the audience would like to speak who is opposed to the short plat. There was no response.

Mrs. Corkrum asked if anyone would like to speak in favor of this short plat. Ray Carlisle spoke in favor.

Hearing was closed to public comment.

**Motion** – Mr. Koch: I move that we grant preliminary approval of Short Plat 2005-15 subject to the seven findings of fact and seven conditions of approval. This is Resolution 2006-026. Second by Mr. Brock. 3:0 vote in favor. (Exhibit 8)

**COUNTY ADMINISTRATOR**

County Administrator Fred Bowen met with the Board.

Courthouse Renovation

Commissioners Meeting Room Chairs: Mr. Bowen asked for approval to order chairs for the meeting room. The Board decided to have seven chairs ordered for the front of the room. Chairs will also be ordered for the audience section.

Superior Courtroom Carpet: The Board decided to have the same carpet installed in the Superior Courtroom as is in the rest of the courthouse.

Work Release Remodel

The Work Release remodel cost breakdown is estimated as follows: \$93,200.00 construction cost, \$13,980.00 for 15% contingency, \$22,915.20 for Clyde Greateorex's salary and benefits, for a total of \$130,095.20. Clyde Greateorex is currently employed by the county as a carpenter.

Courthouse Restoration

The Board asked that the budget for use of the Courthouse Restoration state grant funds be prepared. Two items they would like included in the budget are Public Safety Building roof replacement/repair and painting the cement of the two buildings behind the Courthouse so they match the Courthouse. Mrs. Corkrum would like the painting to be done before the Courthouse is occupied.

Human Resources

Mr. Bowen asked for approval to purchase a two-drawer file cabinet costing \$305 for the Human Resources Department. The **Board approved** paying for it from office supplies line item.

Ben Franklin Transit

Ben Franklin Transit Manager Ed Frost told Mr. Bowen that Transit has put \$250,000 in their 2006 budget for the parking lot work near TRAC. Mr. Bowen said based on estimates in 2004, the parking lot would have cost about \$400,000. He would rather have Transit use the six-acre area on the overflow parking than the current place they are planning to use. When the county improves the parking lots across the street, then Transit parking could be moved to that area. The Board reviewed a drawing of the area. Mr. Bowen suggested the Board approve paving the parking lot in 2006, using land sale funds that are located in the Rainy Day fund. There was discussion about where the Transit transfer station could be located. The Board **gave approval** for Mr. Bowen to continue discussions with Ben Franklin Transit. Mr. Bowen said the plans include water and power.

**TRAC**

TRAC Manager Troy Woody met with the Board.

December Financial Statement

Mr. Woody said the December Financial Statement will be ready shortly. It came out almost exactly break-even for the month. It had been forecasted to lose \$10,000.

Membership in community groups

The Board answered Mr. Woody's questions about his membership as the TRAC Manager in various community groups including the Chamber of Commerce and the Tri-Cities Visitor and Convention Bureau.

Tri-City Herald Reporter Melissa Hoyos joined the audience.

Storage Building

Mr. Woody said the bids close on Tuesday for the new storage building at TRAC. The target date to complete the project is March.

**PUBLIC WORKS**

Engineer Tim Fife met with the Board.

Resolution: CRP 500/East Foster Wells Road Extension Supplemental Agreement  
between JUB Engineers and Franklin County

Mr. Fife said the consultant agreement needs to be extended because the Bureau of Reclamation has not done all they need to do. The Board reviewed the J-U-B Engineers progress report (Exhibit 9).

**Motion** – Mr. Brock: I move for approval of supplemental agreement between Franklin County and JUB Engineers as specified. This is Resolution 2006-027. Second by Mr. Koch. 3:0 vote in favor. (Exhibit 10)

Mr. Fife said we have done everything the Bureau of Reclamation has requested including meeting with wildlife people, preparing to buy additional right-of-way, and providing additional access. The Bureau said they were drafting a letter on October 26 and it would be sent out the next week. However, the county has not received a letter. In addition, phone calls have not been returned. Mr. Fife said it is possible the county will have to go to the level above this for a written response from the Bureau of Reclamation.

Mr. Fife reviewed the history of the project with the Board, explaining how his department has tried to address the issues.

Bi-Monthly Progress Reports

The Board reviewed the Bi-Monthly Progress Reports.

Second 1/4% Real Estate Excise Tax

Mr. Bowen said he thinks the additional 1/4% real estate excise tax would bring in about \$100,000. He believes the Board plans to move ahead to impose the tax and earmark that funding for road improvements. Mr. Bowen asked Mr. Fife if he has looked into what could be done with that amount of money. Mr. Brock said we were still looking at the \$260,000 funding that is available. Mr. Fife said he brought the

information to the Board earlier. He said the \$100,000 would more than cover the needed funding to repay existing debts for the first three to five years.

**COUNTY ADMINISTRATOR (continuing)**

Position Review Consultants for county employees' positions

Mr. Bowen said the proposals received in 2003 for work in 2004 ranged from \$30,000 to \$110,000. He asked for approval to send a request for proposals to have county positions reviewed by consultants to determine appropriate position placement levels. The consultant would have to meet the county's criteria. Mr. Bowen expects the cost range of proposals to be as varied as it was previously. He would like to send the requests for proposal out right away, expecting to receive proposals back in four to six weeks. Then a recommendation would be made for awarding the work. All positions in Franklin County would be reviewed.

Mr. Brock said the Salary Review Committee will still be in place. Mr. Bowen said this work is not for salary adjustments but for position adjustments.

**Motion** – Mr. Brock: So moved. Second by Mr. Koch.

Discussion: The money for the work would come from the Rainy Day fund. Mrs. Corkrum said it's a lot of money. Mr. Bowen said it is a lot of money. He feels it will pay for itself because some employees may be overpaid and some underpaid. For people who are overpaid, the salaries would be frozen until they catch up by years of service. **Vote:** 3:0 vote in favor.

Human Resources: File Cabinet

**Motion** – Mr. Brock: I move for the approval of Resolution 2006-028 as specified. Second by Mr. Koch. Mrs. Corkrum said it is for a two-drawer file cabinet for Human Resources. 3:0 vote in favor. (Exhibit 11)

Resolution and Ordinance repealing Ordinance 23-2002 regarding licensure of methadone treatment facilities

Mr. Verhulp said it is okay to proceed with resolution and repeal of Franklin County's ordinance at this time at a public meeting versus public hearing. A resolution has been drafted repealing the ordinance that established the local methadone treatment facilities here and a subsequent ordinance that carries out the repeal and so forth. The new ordinance allows for state-established laws and regulations. It will prevent any local regulation that Franklin County has conflicting with those regulations.

**Motion** – Mr. Brock: I move the approval of Resolution 2006-029 in the matter of repealing Franklin County Ordinance 23-2002 regarding methadone treatment facilities. Second by Mr. Koch. 2:0 vote in favor. (Exhibit 12)

**Motion** – Mr. Koch: I move approval of Ordinance #2-2006, an ordinance repealing Franklin County Ordinance 23-2002, an ordinance relating to the licensure of methadone treatment and adoption by reference of the alcohol and drug treatment facilities code of the State of Washington. Second by Mr. Brock. 3:0 vote in favor. (Exhibit 13)

**Executive Session** at 10:48 a.m. regarding potential litigation expected to last less than 10 minutes. (Ms. Hoyos left the audience.)

**Open Session** at 10:57 a.m. Ms. Hoyos rejoined the audience.

**Motion** – Mr. Koch: I move that we rescind our consensus of the Civil Service Board application for Bill Clark. Second by Mr. Brock. 3:0 vote in favor.

**Motion** – Mr. Koch: I move for approval of payment of County Road Fund payroll for \$63,885.48; and Motor Vehicle Fund payroll for \$9789.89. Second by Mr. Brock. 3:0 vote in favor.

**OTHER BUSINESS**

The Board suggested using the discarded new carpet from the Superior Courtroom in Child Support and the maintenance office and perhaps other areas. The Board does not want to store the carpet.

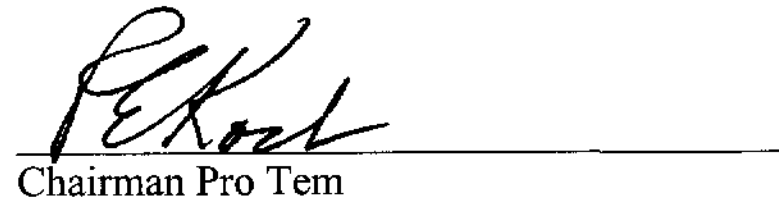

The following represents the progress from the last Memorandum of Understanding dated July 25, 2005 through January 10, 2006:

### USBR CONSULTATION

J-U-B ENGINEERS sent a Memorandum of Understanding to Stephanie Utter, United States Bureau of Reclamation (USBR) Lands Manager, summarizing our last meeting on June 1, 2005. This memorandum is attached for reference. USBR requested the following items:

- Explanation of other public benefits the new roadway would provide in addition to those addressed in the Needs Study
- Summary of information that was presented to the County Commissioners and why the selected alternative was chosen
- Address the compatibility of this project with the goals set for the Columbia Basin Project
- Eliminate the proposed parking area shown in the preliminary plans
- Submittal of detailed plans with the USBR Right-of-Use application.

These materials were submitted with the July 25, 2005 Memorandum of Understanding. Below is a history of contacts J-U-B ENGINEERS has had with USBR since this submittal.

- 9/20/05 Travis Marden discussed the Smith Canyon Crossing with Stephanie Utter and reviewed the Right-of-Use Application materials. The Bureau was asked to provide us with whatever stipulations they may have to allow the proposed crossing. Ms. Utter stated that if Franklin County would acquire the SW1/4 of the SW1/4 of the SE1/4 of Section 1, T. 9 N., R. 30 E. and deed it to the Bureau as a buffer to protect habitat and species located in Smith Canyon, USBR would be amenable to the roadway crossing.

J-U-B discussed the possibility of the land acquisition with Tim and Matt, basically to see if it was a viable option. J-U-B was directed to notify USBR that if the land acquisition was a

condition for the acceptance of the crossing agreement then the County would work towards that solution.

- 10/12/05 J-U-B reached Stephanie Utter to discuss the proposed land acquisition with USBR in further detail and to notify them that the County would work towards the proposed solution, but would like it in writing. Ms. Utter agreed to write a letter stating their conditions for approval and submit it to the South Columbia Basin Irrigation District and copy the County on it.
- 10/26/05 J-U-B called Ms. Utter regarding the status of the letter USBR was preparing for SCBID. We were informed the letter was being written and would be sent out the following week.

Since October, J-U-B has made numerous attempts to contact Ms. Utter to check the status of the letter of condition. The following are noted attempts by our office with voice messages left:

- 11/8/05
- 11/25/05
- 12/28/05

We have been on hold with finalizing this project. Unless directed otherwise we will continue to pursue this resolution with USBR.

At the request of Franklin County, we held a meeting with USBR, Franklin County and J-U-B ENGINEERS, Inc. representatives. Those in attendance were as follows: Matt Mahoney, Franklin County Public Works Department; Rick Door and Travis Marden, J-U-B ENGINEERS, Inc.; Stephanie Utter, Karen Honey and Bill Gray, USBR.

The goal of this meeting was to discuss the potential Scatter Tract issues and to reach a decision or agreement as to process for a decision on the Smith Canyon crossing.

There is no specific wildlife management plan for Smith Canyon.

USBR has the following concerns with the Smith Canyon crossing:

- 1) USBR has an internal 1991 policy of not allowing crossings that sever contiguous parcels of land.
- 2) Impacts to wildlife corridor.
- 3) Equipment being able to cross roadway.
- 4) Public perception.

In 2002 when J-U-B first approached USBR they did not and still do not oppose the project based on the scattered tracts use maps. USBR's main concern is their internal policy of not severing land.

Environmental documentation for this project followed the NEPA requirements due to the federal funding.

The following are items USBR would like additional information on before granting a crossing:

- 1) Address other public benefits in addition to those addressed in the East Foster Wells Road Needs Study.
- 2) Submit a summary of information presented to commissioners and why this alternative was selected.
- 3) Address the compatibility of this project to the goals of the Columbia Basin Project.
- 4) Eliminate the proposed parking area as shown in preliminary design.

- 5) Submit detail plans with the right-of-use application.

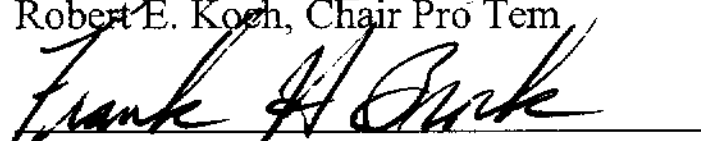

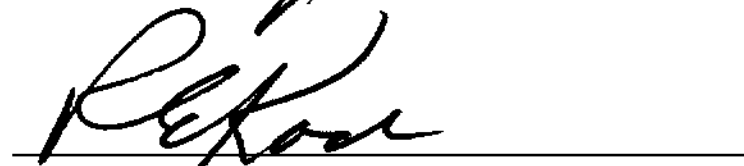

**NOW, THEREFORE, IT IS HEREBY RESOLVED** that Franklin County Ordinance 2-2006, an ordinance relating to the repeal of Franklin County Ordinance 23-2002 be adopted and shall take effect upon the date of approval and signature.

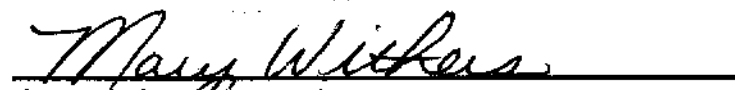
