This request is to purchase equipment for the TRAC telephone system, to add the same 911 capability to TRAC that we currently have at all other County buildings.

Currently, if someone calls 911 from a remote location at TRAC, i.e.; RV Park, Pavillion, Kitchen, etc, the address that is displayed in Dispatch is 6600 Burden Blvd. If an emergency responder were to be dispatched to TRAC, they would go to the office and ask where the problem is. Unfortunately, the front office staff won't know that 911 has been called. More than likely, the responders would leave. Meanwhile someone in stall 12 at the RV Park is having a heart attack, or someone may be injured in the kitchen, etc.

The Commissioner's recognized the liability exposure a few years ago, and approved, adding the technology to identify the specific location of the 911 caller, to the County telephone system. TRAC is the only County facility that does not have this capability.

If you have questions, or if Fred needs me to appear, let me know.
