#### **OFFICE BUSINESS**

Secretary Patricia Shults met with the Board. Present in audience: <u>Tri-City</u> <u>Herald</u> Reporter Joe Chapman.

### Consent Agenda

<u>Motion</u> - Mr. Koch: I move for approval of the consent agenda for April 8, 2009, as presented:

- 1. Approval of **Resolution 2009-137** to salvage three chairs as identified on the *Franklin County Storage Salvage* form received from the Planning and Building Department, in conjunction with RCW 36.32.210 (inventory), and reassign the chairs to the Facilities Department.
- 2. Approval of **Resolution 2009-138** for the Professional Services Agreement between Shelley Ajax and Franklin County to provide legal representation in State of Washington v. Jose Morales, Contract Number FCSC0800SAA001H1.
- 3. Mr. Fife said the R170 project is not included on the list. He briefly explained the history of the R170 project and attempts to get it funded. Mr. Miller suggested all three commissioners call legislators to request that the R170 project be added to the transportation projects list.

### Progress Reports

Mr. Fife gave the Board copies of the bi-monthly Progress Reports. If there is any funding left over from the lighting safety projects, it will be used to flatten slopes on Glade North Road.

#### DISTRICT COURT

Judge Jerry Roach and District Court Administrator Kelly Martin met with the Board. Present in audience: Joe Chapman.

### Department Update

Judge Roach and Ms. Martin gave the Board an update about District Court. A paper listing a brief overview was reviewed (Exhibit 5). Judge Roach said District Court has been using Official Payments Corp to collect some fines since June 2008. It has been an effective tool. Ms. Martin said step increases for employees are not factored into the budget figures on the overview sheet.

In response to Mr. Bowen's question, Ms. Martin said we anticipate revenue to increase. Judge Roach said an amnesty program will begin in May affecting collection amounts. Mr. Bowen explained that he needs information about expected changes to the budget in order to prepare budget forecast information.

### Sacajawea State Park

The Board briefly reviewed some information about the closure or mothballing of some state parks. The Board has prepared a draft letter requesting that Sacagawea Park remain open. Mr. Peck said he still thinks it is appropriate to send the letter but the tone could maybe be shifted a bit. He will review the information in more detail. The Board will decide whether or not to send a letter next week.

## Benton County Engineer Work

Mr. Fife said instead of himself, the Yakima County engineer will be doing the engineering work for Benton County.

Mr. Fife explained some history of why ORC was formed initially. It is a combination of the Technical Advisory Committee (TAC) and the Policy Advisory Committee (PAC).

Mr. Koch asked if the makeup of the committee is what it should be. Mr. Fife said the need for ORC has not gone away but discussion needs to be held about the way it is functioning and deciding if there is some way to make it work better. A lot of elected commissioners cannot attend meetings if they are held during the day. There needs to be discussion about alternates and who they should be. He does not want to disband the ORC until there is further discussion.
