PUBLIC WORKS

Engineer Tim Fife, Public Works Accountant Dennis Huston and Public Works Maintenance Director Darrel Farnsworth met with the Board.

Equipment Rental Rates

Staff responded to the Board's questions about the legal foundation for the rates, what equipment is covered, the effective dates and the dollar amount involved for October through December 2009. The resolution adopting the equipment rental rates will be placed on the next consent agenda.

Lease with City of Pasco for Courthouse Space

The City of Pasco needs to know the county's intentions so they can start making their plans.
