Mr. Bowen said the county attorney can think of no legal reason that a commissioner cannot use county letterhead as a county commissioner.

Mr. Peck said a commissioner who is signing on behalf of the whole board can state that either in the body of the letter or on the signature line.

Information Services: New position, Communications Engineer

Mr. Scott requested approval of a new position in Information Services called Communications Engineer. The person filling the position will manage both the radio and microwave systems. It is part of the 911 system. In the past we've had to rely on vendors to do the work. The position has been reviewed and approved by the Salary Classification Committee.

**Open Session** at 10:29 am. Michelle Dupler rejoined the audience.

In answer to a question, Mr. Bush answered questions regarding the funding sources.

<u>Motion</u> – Mr. Koch: I move for approval of Resolution 2009-517, approval of Franklin County personnel division request for a communication engineer. Second by Mr. Peck. 3:0 vote in favor.

Mr. Scott and Mr. Bush left the meeting.

#### Budget Transfer: 480 Volt Kitchen Heater

Mr. Bowen received a request this morning to approve installation of a heater in the Corrections Center (jail) kitchen. He answered the Board's questions about the current heating situation, the replacement heating system, and the cost.

<u>Motion</u> – Mr. Peck: Mr. Chair, I would move that we authorize Facilities to purchase and install a heater in Franklin County Corrections Center kitchen, create a line item, and

authorize an inter budget transfer, all as presented in the resolution before us. Second by Mr. Koch. Mr. Koch questioned why the Board did not have the request prior to the Board meeting. Mr. Bowen explained it is a safety issue. 3:0 vote in favor.

He would like to support the Columbia Basin Development League and feels it is a benefit to Franklin County. Mr. Peck said I think it's a great organization but it's a lobby organization and it is illegal for us to spend money for those lobbying activities/organizations. Mr. Miller asked if the Ground Water Management Area (GWMA) would be the same. Mr. Peck does not think it is the same as GWMA. Mr. Koch asked about the work done for the county by Jim Potts. Mr. Peck said Jim Potts' work is allowed under the RCW because we're allowed to spend funds for informational purposes.

Mr. Peck suggested that any time the Board receives requests for membership fees, legal counsel should review the request.
