The Honorable Board of Franklin County Commissioners met on the above date in a Special Board Meeting. Present for the meeting were Brad Peck, Chairman; Rick Miller, Chair Pro Tem; and Bob Koch, Member; and Mary Withers, Clerk to the Board. Fred Bowen, County Administrator, was absent on personal business. Meeting convened at 9:00 am.

HUMAN RESOURCES (HR)

HR Director Rosie H. Rumsey met with the Board. Present in audience: Assistant HR Director Lisa Schumacher; Stephanie B. Green from USW Local 12-369, Len Shure from BOP Local Corrections, Sandy Schroeder from Franklin County Correctional Center, County Engineer Tim Fife, Deputy Prosecutor Ryan Verhulp, Rick Long from Franklin County Correctional Center, Connie Curiel from Franklin County Auditor's Office, Raenette Carle, Laura Stark, Jerrod MacPherson, Peter McEnderfer, Steve Marks, Adam Morasch and <u>Tri-City Herald</u> Reporter Kristi Pihl.

2011 Employee Benefits

Ms. Rumsey told the Board that Washington Counties Insurance Pool (WCIP) has decided to disband effective January 1, 2011. She explained differences between the Washington Counties Insurance Fund (WCIF) and WCIP. She told the Board about employee medical insurance options and answered questions.

The WCIP currently feels there are enough reserve funds to pay what is required. If not, all the counties and entities in the pool will be assessed. The open enrollment date for employees has been extended to December 1, 2010. Ms. Rumsey recommended that the Insurance Committee should be reinstated. If the county chooses to use Premera Insurance, the cost would be a 5.7% increase for 2011 in addition to the previously known increase of approximately 24%.

Ms. Rumsey told the Board about changes in the procedure to give notice to withdraw from WCIF.

The Board then spoke by telephone with Mike Shelton, Executive Director of WCIF/WCIP.

The Board continued the discussion about insurance after the phone call.

Mr. Koch cautioned that whoever might be looking for insurance should be aware of what's available and how the costs have increased for counties and entities not using the WCIP in the last two or three years.

Mr. Peck listed some options. One is to use Premera in 2011 and also implement a search committee to review future options. A second option is to have the Insurance Committee attempt to find a more desirable or more acceptable plan for 2011 but that would have to be accomplished in the next two weeks, finalized by the end of November. A third option would be to use Premera, reinstate the Insurance Committee, obtain bids, and then if we find something we desire that is better, give 90 days' notice and pull out during the year.

In response to a question, Ms. Rumsey said a parity rule is in effect so Premera will not bid against themselves to provide cheaper insurance.

Mr. Peck asked who would participate on an insurance committee. Ms. Rumsey said it would include members from each union, elected officials, and non-bargaining employees.

Ms. Rumsey has ordered a claims history for Franklin County only. She will begin preparing a census for the Franklin County group. In the future, Premera will not give Franklin County its own separate claims history.

Mr. Peck asked, given rates in pools are going up exponentially, is there any kind of viable option for the county to pay employees a set amount and allow them to secure insurance any way they choose? Ms. Rumsey said that is an option. It would be a true cafeteria plan. The Insurance Committee could prepare a list of providers. Mr. Peck said he is not necessarily for or against that approach but that is an option.

Executive Session at 9:50 am expected to last 10 minutes based on RCW 42.30.140(4)(b) regarding collective bargaining agreements/grievance discussion. Ms. Rumsey and Ms. Schumacher remained in the meeting with the Commissioners.

Executive Session continued at 10:00 am expected to last up to 15 minutes. Those waiting outside were notified.

Open Session at 10:16 am.

Tim Fife, Laura Stark, Sandy Schroeder and Kristi Pihl joined the audience.
