Columbia River Crossing

A Columbia River Crossing meeting will be held on April 29 to review the study which recommended three options. Mr. Koch is the county's appointee to the committee but will not be able to attend. He believes one or both of the other commissioners should be there. Mr. Fife will attend and be available as a technical reference but will not give an opinion on behalf of the Board.

Mr. Miller said that as Commissioners, we have not come to an understanding of what we think so even for us as Commissioners to say anything would be incorrect at this time. Mr. Peck and Mr. Koch agreed. Mr. Peck asked if the Board wants to discuss the matter at a future Board

meeting prior to the April 29 meeting so whomever we send is ready to present Franklin County's position.

Mr. Koch said he feels the April 29 meeting will not be so much about which crossing option will be used but the option of if we're ready to go out and look for some money to go forward. The decision about which crossing will come after the SEPA process is completed. Mr. Koch agreed the Board needs to spend some time to discuss the issue.

Mr. Peck said when we have that discussion I'm going to advocate for us taking a position on which crossing we think is most beneficial to the county, based on what we know now, reserving final judgment until the SEPA is done.

OTHER BUSINESS

Ag Burn Permits

Franklin Conservation District Director Mark Nielson, Chief Civil Deputy Prosecutor Ryan Verhulp and Planning Director Jerrod MacPherson met with the Board. Present in audience: Kristi Pihl.

Mr. Nielson said he would like the county to cover defense costs for the Conservation District if the situation ever occurs. Mr. Peck asked could the Conservation District use a portion of the burn permit fees to buy insurance? Mr. Nielson said it is extremely difficult to buy pollution exclusion type of insurance. The cost is unknown. Language in the burn permit was reviewed.

Rick Miller suggested looking at getting outside insurance and maybe adding the cost to the permit fee. He would like the Conservation District to be handling the permits at this time. He thinks we can work on legislation again next year.

Mr. Nielson noted that there have been no claims or lawsuits regarding burn permits in the nine years the Conservation District has been issuing permits.

Mr. Peck expressed the importance of agriculture to Franklin County and asked the Board to approve the agreement with the Conservation District and continue to take the risk as we have been doing, while aggressively working to get the liability portion changed in the state law.

Mr. Miller and Mr. Koch are in favor of approving the contract. Mr. Verhulp answered Mr. Peck's questions about review of the contract.

<u>Motion</u> – Mr. Peck: I move that we move forward with approving the agreement with Franklin Conservation District as presented, recognizing that this is in all meaningful respects the same agreement we have done in the last several years. Second by Mr. Miller. Mr. Nielson said the contract is on a two-year cycle. 3:0 vote in favor. Resolution 2011-120 was approved. **Adjourned** at 11:10 am.

There being no further business, the Franklin County Board of Commissioners meeting was adjourned until April 11, 2011.
