Update on Extension activities in Franklin County

Extension volunteer opportunities

Ms. Sherfey presented an idea to increase capacity in county departments through using volunteers without increasing the budget. She said WSU Extension has the capacity to manage a volunteer system for Franklin County and listed some of the work WSU Extension can do including covering L&I costs, checking references, doing background checks, and conducting interviews. She asked for Board support to move forward and identification of at least the first department that would be receptive. The Board members asked for time to study the proposal.

Broadband Installation Issue
