### Sanderson Estates

William Pennell, president of the Sanderson Estates Fire Protection System LLC, met with the Board. He referred to a letter sent to the Commissioners about fire protection in five

developments (Exhibit 5) and said residents of the areas have had some additional discussion since the letter was written. He emphasized that we are not asking the county to take over the system. We are asking for help to propose a solution. He said we've decided that perhaps the most feasible route to go to solve this problem would be to petition the county under RCW 57 for the creation of a water district, the boundaries of which would encompass the five plats that are served by this system. That process would require a petition signed by 10% of voters. It would then be submitted to the county commission. Mr. Pennell explained some of the process involved. He said we also wanted to see if there were any other possible ideas to deal with the financial and legal liability.

He said we also need to know what the consequences would be if the voters would vote against the establishment of this new taxing district.

Mr. Pennell introduced Tom Lenberg, one of the directors, and Mary Rosen, the secretary. He referred to RCW 57 and said since we have no way of raising funds to make sure a fire protection system meets the needs for which it is intended, we need to have a sustainable stream of revenue and also finance future improvements and repairs.

Mr. Koch said there are some options as far as working with Fire District 3. There was discussion. Mr. Peck asked Mr. Koch on behalf of the board to take the lead on this issue and help you walk through the process to the extent that's reasonable. Mr. Koch agreed to do that.

The Board approved a letter in response to the Sanderson Estates Fire Protection System, LLC, referring to five plats: Dream View Estates Property Owners Association, Sanderson Estates Homeowners Association, Sanderson Heights South Homeowners Association, Sanderson Heights Property Owners Association, and Montecello Estates (Exhibit 6) Discussion about Public Comment during meetings

The Board decided to add a Public Comment section to the agenda at the beginning of Office Business and during the Other Business portion of its meetings.

Dear Commissioner Peck,

We are writing you and your fellow commissioners as the Board of Directors of the Sanderson Estates Fire Protection System, LLC. The LLC owns a fire protection system, consisting of various pumps, control systems, piping and fire hydrants, that serves five plats located off Kohler Road in Franklin County. The five plats total 88 lots and some 67 single-family residences, ranging from several hundred thousand to over one million dollars in assessed value.

The developers of these plats were required by the county to install a full fire-flow protection system before the county would approve their development. However, the county failed to require or provide for a mechanism to pay for the continued operation and maintenance of this system. Because the county's failure to provide for a sustainable fire protection infrastructure at the approval stages of these developments is the cause of this problem, we are petitioning the Franklin County Board of Commissions to work with us to find a remedy for this untenable situation.

In 2011 Sanderson Heights, LLC, which originally built and operated the fire protection system, transferred ownership of it to the Sanderson Estates Fire Protection System, LLC. The Sanderson Estates Fire Protection System was established in order to operate the fire protection system by four property owners associations that represent four of the five plats. (One of the plats, Montecello Estates, does not have a property owners association; thus, it is not an owner of the system, although it is served by it.) We originally, and naively, thought that it would be possible to maintain and operate the system within the existing budgets of our property owner associations; however, this assumption has proved false for the following reasons:

- 1. We estimate the annual cost of operating and maintaining the system to be \$150-\$200 per lot, with a significant fraction of this cost being liability insurance. This insurance is an absolute requirement, and the board cannot accept responsibility for continuing to operate this system without it.
- 2. While the above amount may seem to be a trivial cost for our homeowners, we have no mechanism for raising these funds. The estimated annual cost of maintaining and operating the fire protection system exceeds the current annual dues assessed by our associations. Moreover, only three of the four property owners associations have provisions in their by-laws for assessing annual dues. Thus, we have absolutely no means of assessing operating costs for 30% of the properties served by the system. The implications of this fact were made clear shortly after we assumed responsibility for the system. We found that it was

inoperable. We contracted for repairs, which came to a couple of thousand dollars, and 9 months after completion of the work we have still been unable to collect all the money required to pay off the contractor who did the work. The three associations that do have annual assessments categorically refuse to subsidize those property owners who cannot or will not pay, and this includes those association members who may choose not to pay their annual dues.

We cannot continue to take responsibility for this system under these conditions, and if a solution to the funding problem is not found, we will have no choice but to liquidate the LLC along with its assets. Without liability insurance, which is our principal cost driver, we are exposed to considerable personal liability should any loss result from failure of the fire protection system. In fact, some of us have been advised by our personal attorneys to sever any connection with the Sanderson Estates Fire Protection System in order to protect ourselves from such liability. As responsible citizens of our community, however, we are reluctant to do so until a workable solution can be found. And we do have a couple of suggestions along these lines:

- 1. Under Section 8 of the Franklin County Fire Code, provision of on-site water storage can substitute for a full fire-flow system "where the development of full fire-flow requirements is impractical." As we cannot possibly pay for the cost of maintaining a full fire-flow system under the current situation, our continuing to maintain this system is clearly impractical. We do have a 38,776-gallon reservoir as part of the system. We believe that we could maintain this reservoir as a fire protection system at a cost that could be borne by the revenue-generating property owners associations. However, this would require a finding by the county that the reservoir meets the requirements of the fire code for all five plats. It also means that we would remove the existing fire pump, controls, and fire hydrants and apply salvage revenues to pay for any modifications to the existing reservoir that might be required to make it more easily accessible to fire trucks.
- 2. If it is determined that we must maintain the existing system, it must be financed through property taxes applied to all benefitted properties. We presume that this would require creation of some sort of special taxing district. However, we see the establishment of such a district as the responsibility of the county and not of the individual property owners. In fact, we would need at least one year's worth of working capital before we could even begin to operate a tax-supported system, because there would certainly be some lag time between when a taxing district could be established and when revenues would begin to flow into it, and liability insurance must be obtained now. Where that initial working capital would come from is a mystery.

As you can see, there is no simple solution to this problem, and it is further complicated by recent knowledge that the system has broken down again, is currently inoperable, and requires additional repair. We do not want to liquidate this system. We recognize that this action would place all five plats out of compliance with the county fire code, which could affect our property values and preclude the building of any additional houses in this area. However, the policies of the county are responsible for this fiasco, and as Franklin

County taxpayers and voters, we expect the county to take the lead in solving this problem. We will be expecting to hear from you in the very near future.

### Gentlemen:

Thank you for your letter of April 27, 2012. Our research shows that at the time of approval of each of the subdivisions for the five plats you represent, the county required each subdivision in its application to set forth as a condition of approval the fire protection system that was installed. Each subdivision agreed to the fire protection requirements.

Title 52 of the Revised Code of Washington (RCW) governs fire protection districts (FPD). Per RCW 52.02.020, FPDs are for the provision of fire prevention and suppression services to protect life and property "in areas outside of cities and towns." This RCW indicates FPDs are specifically tasked with these services rather than counties.

Once an FPD exists, per RCW 52.20.010, local improvement districts (LIDs) within the FPD may be initiated to acquire, maintain and operate apparatus and instrumentalities to provide fire protection services by (1) resolution of the Board of Fire Commissioners or (2) by the owners of a majority of the acreage of lands within the LID submitting a signed petition to the FPD. If the FPD receives a petition, the RCW requires the FPD to approve or dismiss the petition. Of course, this RCW contemplates the operation and maintenance of an existing fire protection system like that serving Sanderson Heights. This RCW also outlines the procedure for either the FPD to initiate a "resolution" or the procedure for the owners to submit a "petition" which could be provided to the owners in the Sanderson Heights area so they can initiate the process of having this issue addressed.

We recommend you consider using one of the methods outlined in RCW 52.20.010 as detailed above. You may also want to consider contacting Franklin County Fire Protection District Number 3 to determine if it is possible and/or desirable to petition to be included in a district LID.

We do not have any contact information for owners of Montecello Estates. Please consider forwarding this letter to them for their information.

It should be recognized this letter is for informational purposes only and is not legal advice or a substitute for legal counsel. It is recommended that the residents of the Sanderson Heights area seek their own legal counsel to obtain advice regarding this matter.
