The Honorable Board of Franklin County Commissioners met on the above date. Present for the meeting were Brad Peck, Chairman; Rick Miller, Chair Pro Tem; and Robert E. Koch, Member; Fred Bowen, County Administrator; and Mary Withers, Clerk to the Board. Meeting convened at 9:00 am.

#### **PUBLIC WORKS**

Interim Public Works Director Guy Walters met with the Board. Present in audience: Jim Follansbee, Rich Lahtinen and Tri-City Herald Reporter John Trumbo.

Discussion about presentation to Washington State Transportation Commission

Mr. Walters and the Board reviewed a draft presentation on the screen about major accomplishments and challenges and needs for Franklin County roads. Some changes will be made prior to giving the presentation to the Washington State Transportation Commission.

Mr. Walters noted three major projects have been completed over the last three years: R170 landslide project, East Foster Wells Extension Phase 2, and Road 100 extension/Dent Road. All have been built to an all-weather standard. The greatest challenge is because of 391 miles of gravel roads. Another challenge is the need to add to the all-weather road system.

#### Road question

At Mr. Peck's request, Mr. Walters told the Board about efforts to determine whether a road is a county road or private property.

#### Bell Street

Road Supervisor Gary Fitch met with a property owner on Bell Street regarding a water ponding problem. It is possible that a catch basin will be installed to correct the problem.

#### <u>TRAC</u>

Mr. Miller suggested asking the TRAC Advisory Board to give us an analysis regarding future projects of TRAC that they think would make TRAC sustainable. Mr. Koch is not opposed. Mr. Peck is not opposed but is not convinced that the TRAC Advisory Board is necessarily the best entity to look at that, being as they advise.

Mr. Bowen said at least three consultants studies have been done over the past 20 years. All have recommended upgrading the facility in order to change the types of events that can be held at TRAC. Some items noted in the studies have included: seating is inadequate, the dirt floor is a hindrance, lack of sufficient restrooms, and no concession stands. Those upgrades are expected to bring in more concerts and other events because they would cater to the needs.

There was brief discussion regarding the TRAC Advisory Board's duties.

The **Board agreed** to request that the TRAC Advisory Board give us their recommendations for the future of TRAC including what if any investments or facility changes they might recommend.

Internal Investigation

Mr. Miller thinks a report regarding an internal county investigation should be released, maybe with redactions. Mr. Peck recommended Mr. Miller take it up with the PA's office who has made the legal recommendation that it is in the county's best legal position not to release it. Mr. Miller disagrees.

<u>Motion</u> – Mr. Miller: I'd like to make a motion that we do release the internal investigation. Motion died for lack of a second.

#### **PUBLIC COMMENT**

John Trumbo, Tri-City Herald Reporter, met with the Board. Present in audience: Margo Hines and Jim Follansbee.

He told Mr. Trumbo he supports his request and is just asking for a little additional time to get all ready. Mr. Koch agreed. Mr. Miller said I agree we should put that out to the public.
