Commissioners' Proceedings for June 11, 2014

This document is a summarized version of the Board of Commissioners proceedings. The minutes are paraphrased, not verbatim. Access to an electronic audio recording of the meeting is available upon request.

The Honorable Board of Franklin County Commissioners met on the above date. Present for the meeting were Robert E. Koch, Chairman; Brad Peck, Chair Pro Tem; and Rick Miller, Member; Fred Bowen, County Administrator; and Margo Hines, Pro Tem Clerk to the Board. Meeting convened at 9:00 am with the Pledge of Allegiance.

#### **PUBLIC WORKS**

Public Works Director Matt Mahoney and Engineer Matthew Rasmussen met with the Board. Present in audience: Kevin Kossel from James A. Sewell & Associates; Robert Andrews, Dan Winder and Bret Gledhill from Basin City Water and Sewer District; Kathleen Neuman from Public Works Department; Tracy Diaz, Bill Dixon, Marianne Ophardt, and others. Rejection of Bids: CRP 606 Langford Road Resurfacing and Restoration Project

Mr. Mahoney and Mr. Rasmussen answered the Board's questions. The scope of work for the project will be reduced and then the project will be re-bid.

<u>Motion</u> – Mr. Miller moved to reject all bids. Second by Mr. Peck. 3:0 vote in favor. (Exhibit 1)

# Comprehensive Parking ordinance

Mr. Mahoney summarized the details of the comprehensive parking ordinance.

The Board gave consensus approval to hold a public hearing about the comprehensive parking ordinance.

2014 Community Development Block Grant (CDBG) application, sub-recipient Basin City Water and Sewer District

Kevin Kassel from James A. Sewell & Associates met with the Board. Robert Andrews, Dan Winder and Bret Gledhill from Basin City Water and Sewer District were also present. Others were present in the audience.

Mr. Rasmussen explained what work has already been done and what work remains to be done.

Mr. Kassel explained the need for the project. The grant application is for \$750,000. He said we think it is enough money to complete the project. Amounts for design, inspection and administration are included in the grant application.

Dan Winder, Chair of Basin City Water and Sewer District, thanked the Franklin County Commissioners and Public Works staff for their involvement in the projects and explained the need for the new project. Mr. Peck said the money being used is taxpayer money.

<u>Motion</u> – Mr. Miller moved to support the grant application for the Basin City Water and Sewer District in the amount of \$750,000. Second by Mr. Peck. 3:0 vote in favor. Resolution 2014-257 was approved.

# Complaint regarding parking on Road 88

The Board discussed a complaint received about parking on Road 88. No action was taken.

### New Right-of-Way Vacation Ordinance - Draft for Discussion

Mr. Mahoney asked if the Board wanted to review the draft right-of-way ordinance further before it is submitted to the Prosecutor's Office for review. The Board gave approval to have the document reviewed by the Prosecutor's Office and schedule the matter for a public hearing.

Ms. Diaz said preliminary data from the Department of Commerce shows that Benton-Franklin Counties have one of the highest reductions of homelessness in the state at 44%. The full report will be released in about a month.

Ms. Diaz explained each contract and answered the Board's questions.

<u>Motion</u> – Mr. Peck moved for approval of First Amendment to Agreement #2014-HHAA-DVS between Benton and Franklin Counties Department of Human Services and Domestic Violence Services of Benton and Franklin Counties with a net fiscal impact of zero and a dedication of \$700 for this purpose. Second by Mr. Miller. 3:0 vote in favor. Resolution 2014-259 was approved.

Grant Agreement #2060-2014-CBVC between Benton and Franklin Counties Department of Human Services and Columbia Basin Veterans Coalition

Ms. Diaz answered the Board's questions about the Columbia Basin Veterans Coalition grant. Mr. Peck would like the amount contributed by Franklin County to be the normal prorated amount of 30% with Benton County paying 70%. The Board gave direction to Ms. Diaz to take the grant back to the Steering Committee rather than approve it at this time.

SUBJECT: CRP606 Langford Road Resurfacing and Restoration Project

On May 28, 2014, at the regular meeting of the Board of County Commissioners, two (2) bids were received for the above referenced project. The apparent low bidder was Central Washington Asphalt of Moses Lake, Washington, in the amount of \$498,498.00. The engineers estimate was \$374,979.00. A complete summary of all bids received is included in the attached bid tabulation.

All bids have been evaluated by Matt Rasmussen, County Engineer/Assistant Public Works Director in accordance with the contract documents. While all bids appear to be responsive the amount of the lowest bid exceeds the available funds for the project.

Due to the lack of funds to pay the proposed contract amount it is my recommendation to reject all bids and rebid the project with a reduced scope and revised contract documents that should result in more favorable pricing. The Contract will be revised and re-bid as soon as possible.
