Commissioners' Proceedings for October 21, 2015

The Honorable Board of Franklin County Commissioners met on the above date. Present for the meeting were Brad Peck, Chairman; Rick Miller, Chair Pro Tem; and Robert E. Koch, Member; Keith Johnson, County Administrator; and Mary Withers, Clerk to the Board. Meeting convened at 9:00 am with the Pledge of Allegiance.

PUBLIC HEARING: to consider increasing Revenue and Expenditures Bottom Lines of the 2015 Franklin County E911 Miscellaneous Fund, Number 139-000-001 by \$500,000 for a total appropriation for \$1,739,628

Public Hearing convened at 9:04 am. At Mr. Peck's request, Dispatch Superintendent Ed Bush gave a summary of the requested increase. Present in audience: Jerrod MacPherson, Mike Namchek, Carlee Nave, Tom Westerman, Sheriff Jim Raymond and one other man.

Dispatch Superintendent Ed Bush met with the Board.

Mr. Peck asked three times if anyone in the audience would like to comment. There was no response.

<u>Motion</u> - Mr. Koch: Mr. Chairman, I would move for the increase of revenue and expenditure bottoms lines of the 2015 Franklin County E911 Miscellaneous fund by \$500,000 for a total appropriation of \$1,739,628. Resolution 2015-370 was approved.
