COMMISSION PROCEEDINGS NOVEMBER 4, 2015

CALL TO ORDER

Commission Chairman, Brad Peck called the Franklin County Commissioners' Regular meeting to order at 9:00 a.m., in the Commissioners' Meeting Room in the Franklin County Courthouse located at 1016 North Fourth Avenue, Pasco, Washington.

PLEDGE OF ALLEGIANCE

Commissioner Peck led the Pledge of Allegiance.

PUBLIC WORKS BID OPENING

Construction Contract for County Road Maintenance Project (CRMP) 2014-02 Hendricks Bridge Repair

Public Works Director Matt Mahoney explained repairs were necessary for Hendricks Bridge due to an incident that occurred August 19, 2014. On January 14, 2015 the Franklin County Boards of Commissioners awarded a Personal Service Contract (Resolution 2015-013) to Anderson Perry & Associates, Inc., of Walla Walla, Washington to make recommendations and design a bid-ready solution for the repair.

An Invitation to Bid was published in the October 14 and October 21 editions of the *Franklin County Graphic* as well as in the October 14, 2015 edition of the *Tri-City Herald*.

Mr. Mahoney recommended proceeding with the bid opening.

PRESENTATION BY CATHY MERRILL HOLLE AND EILEEN GRIGSBY OF COMMUNITY ACTION CONNECTIONS

Ms. Cathy Merrill Holle and Eileen Grigsby presented the annual report to the Board reviewing the 2015 Community Needs Assessment and Inventory of Community Assets.

Ms. Holle felt it was important to understand real and perceived needs and issues facing the eligible families, to identify resources, enhance community collaboration and partnerships and to avoid duplication of services.

Ms. Grigsby gave a PowerPoint presentation showing several statistics for Benton and Franklin Counties. She explained the top needs were housing assistance, help with short term shelter assistance, energy assistance and dental services.

She explained increasing awareness of services and educating community about available services and assistance was important as identifying and decreasing long waitlists. There also needs to be more collaboration between organizations.

The Board thanked Ms. Holle and Ms. Grigsby for their presentation.

There was discussion of whether the County was responsible for providing wireless services at Franklin County RV Park and whether the DIRECTV contract had undergone legal review.

After extensive discussion of the legality of the contract as it pertains to a government agency, the previous motion to approve Consent Agenda Items one through eight was rescinded.

Commissioner Miller moved to approve Consent Agenda Items two through eight. Commissioner Koch seconded and the motion was carried unanimously.

COUNTY ADMINISTRATOR

- Procurement of Cell Phones for Auditor and Treasurer: County Administrator Keith
 Johnson felt it would be more appropriate for elected officials to use a County-owned
 device rather than personal cell phone. Due to the rapid changes with technology more
 texts are being sent. Although technology is close to having the capability of capturing
 the content of texts it would be impossible to distinguish personal texts from businessrelated texts.
 - After discussion, Commissioner Miller moved to approve the procurement of cell phones for the Auditor and Treasurer. Commissioner Koch seconded and the motion carried. (Resolution 2015-394)
- <u>Juvenile Justice Center and Superior Court Contributions Discussion</u>: Mr. Johnson reviewed correspondence he had drafted to Benton County recognizing the need for discussion regarding the Juvenile Justice Center and Superior Court operations.

After discussion, it was to revise the letter slightly and send to Benton County Commissioners.

Other Business

Mr. Johnson explained Benton County Commissioners took action during the Nov 3, 2015 meeting regarding mental health services and will be requesting a bicounty meeting to discuss the future of the agency. Because of a new

administration at Franklin County, Mr. Johnson felt speaking with Benton County Administrator David Sparks prior to a bi-county meeting would be beneficial to the resolving the issues involving both the Juvenile Justice Center and Superior Court.

After discussion, it was decided Mr. Johnson would meet with Mr. Sparks and begin the process of organizing an advisory committee. The committee would present a recommendation to both Boards.
