CALL TO ORDER

Commission Chairman, Brad Peck called the Franklin County Commissioners' Regular Board Meeting and 2016 Budget Hearing to order at 9:00 a.m., in the Commissioners' Meeting Room in the Franklin County Courthouse located at 1016 North Fourth Avenue, Pasco, Washington.

PRESENTATION BY THE PORT OF PASCO ECONOMIC DEVELOPMENT DIRECTOR GARY BALLEW

Mr. Ballew addressed the Board explaining Port of Pasco, in close cooperation with Greater Pasco Area Chamber of Commerce, is leading a community-wide effort to develop an economic strategic vision for the Greater Pasco area. He further explained this vision will align the community's resources toward a singular economic vision. The intent of this effort is to identify opportunities for economic growth through analysis of Pasco's attributes and to match those attributes with market research of economic development opportunities targeting interaction of the growing Latino majority in Pasco.

Mr. Ballew stated much of the pre-planning was completed and there had been initial community discussions and research to set the groundwork for creating the Vision. Port of Pasco funded the first phase but he explained the next phase will require financial support from community partners.

Mr. Ballew stated the Port is seeking a \$50,000 US Economic Development Administration (EDA) grant which would fund fifty (50%) percent of the projected cost.

He explained remaining funds would come from other community partners including Columbia Basin College and City of Pasco and asked the Board to consider contributing \$25,000 from the 0.09 monies.

The Board thanked Mr. Ballew for his presentation and agreed to consider the request.

HANFORD COMMUNITIES ANNUAL REPORT BY PAM LARSEN

Ms. Larsen first thanked Commissioner Miller for serving on the Governing and Administrative Boards.

She explained she was present today to give the annual update for Hanford Communities. She stated Energy Communities Alliance was working with other communities on options for disposal of high level waste. Department of Energy requested a discussion regarding Wild Land Fire coordination and she was also working with TRIDEC on the Energy Park. She has been in frequent communication US Senators' staff and met with Governor Inslee's new eastern Washington staffer, Melissa Carpenter.

Ms. Larsen stated next year's agenda would include a national policy on high level waste disposition and consent decree litigation.

The Board thanked Ms. Larsen for her update.

OPENED 2016 BUDGET HEARING TO HEAR COMMENT REGARDING THE 2016 BUDGET

Commissioner Peck recessed the Regular meeting at 9:55 a.m., and opened the Public Hearing to hear public comment regarding the 2016 Budget.

CLOSED 2016 BUDGET HEARING

Hearing no public comment, Commissioners Peck closed the Public Hearing at 9:55 a.m.

ADOPTION OF 2016 BUDGET

After a brief discussion, Commissioner Koch moved to approve Resolution 2015-476 with a levy amount of \$3,145,943, increasing the 2016 Levy for Franklin County Road Department by one-percent (1%), making the dollar amount of the increase over the actual levy amount from the previous year \$31,459.00. Commissioner Miller seconded and the motion was carried.

- Commissioner Koch moved to approve Resolution 2015-477 with a levy amount of \$7,948,310, increasing the 2016 Levy for Franklin County by one-percent (1%) making the dollar amount of the increase over the actual levy amount from the previous year \$79,483.00. Commissioner Miller seconded and the motion was carried.
- Commissioner Koch moved to authorize the Franklin County Assessor to levy the minimum amount allowable by statute generated from the property tax assessment for the Veteran's Assistance Fund (commonly referred to as Soldiers and Sailors Fund) for the 2016 budget year. Commissioner Miller seconded and the motion was carried.
- Commissioner Miller moved to approve Resolution 2015-478 adopting the Franklin County 2016 Miscellaneous Fund Budgets in the amount of \$36,433.103. Commissioner Koch seconded and the motion carried.
- Commissioner Peck moved to approve Resolution 2015-479 adopting the Franklin County 2016 Current Expense Budget as a bottom line budget in the amount of \$29, 683,726. Commissioner Koch seconded and the motion carried.
- Commissioner Koch moved to approve Resolution 2015-480 establishing a substantial need, due to the substantial increase in the staffing levels of the 2016 Department of Corrections budget, and herby approve the 2016 property tax levy limit at one-percent (1%). Commissioner Miller seconded and the motion carried.

Commissioner Peck stated this was an extraordinary year due to the needs of the Sheriff's Department; needs due to under-budgeting by the former regime. He said the Board would not hesitate to reopen the 2016 budget if necessary. Commissioner Peck express concern regarding the Coroner's intention to hold an inquest when he had not come to the Board to discuss additional funding associated with such an inquest.
