REGULAR MEETING AND PUBLIC HEARING MINUTES

JANUARY 13, 2016

CALL TO ORDER

Commission Chair Rick Miller called the Franklin County Commissioners' Regular Board Meeting to order at 9:00 a.m., in the Commissioners' Meeting Room in the Franklin County Courthouse located at 1016 North Fourth Avenue, Pasco, Washington.

PLEDGE OF ALLEGIANCE

Commissioner Miller led the Pledge of Allegiance.

PUBLIC HEARING

Commissioner Miller recessed the Regular meeting and opened the Public Hearing at 9:01 a.m.

TRAC Accounting Assistant Tiffany Coffland addressed the Board stating in order to pay 2015 TRAC expenses, the bottom line of both the 2015 revenue and expenditure budget needed to be increased by an additional \$125,000. She stated TRAC revenues have exceeded the 2015 Budget by approximately \$50,000 and it is estimated that expenses will exceed 2015 Expenditure Budget by \$125,000. She informed the Board it was mostly caused by unbudgeted expenses including increased medical insurance expenses and two payouts to resigning employees for accrued sick and vacation hours.

CLOSED PUBLIC HEARING and RECONVEN REGULAR MEETING

After a brief discussion, Commissioner Miller closed the Public Hearing and reconvened the Regular meeting at 9:13 a.m.

Commissioner Koch moved to approve Resolution 2016-010 increasing Revenue and Expenditure bottom lines of 2015 Miscellaneous Franklin County TRAC Facility Fund by \$125,000. Commissioner Peck second and the motion carried unanimously.

FRANKLIN COUNTY HORTICULTURAL PEST AND DISEASE CONTROL BOARD

Horticultural Pest and Disease Control Board Coordinator Tom Wilson addressed the Board stating three members needed to be appointed to the Horticultural Pest and Disease Control Board. Per RCW 15.09.030, each Horticultural Pest and Disease Control Board shall be comprised of five voting members, four of whom shall be appointed by the Board of County Commissioners.

Mr. Wilson stated Mike Sullivan, Ed Skelton and Pam Gilmore have applied to serve on the Board and he recommended the Board of County Commissioners appoint all three individuals to the Horticultural Pest and Disease Control Board.

Commissioner Peck asked if the vacancies were advertised. Mr. Wilson said they had advertised in the past with no response and wanted to appointed willing citizens. Commissioner Peck requested that all future vacancies be advertised on the Franklin County website.

Mr. Koch Moved to approve Resolution 2016-011 appointing Mike a Sullivan, Ed Skelton and Pam Gilmore to the Pest Board Mr. Peck seconded and the motion carried.

LOBBYIST UPDATE

Mr. Zac Kennedy gave a brief update of current legislation in Olympia, Washington including that House Bill 2348 providing local governments with flexibility regarding local fireworks ordinances would go into effect immediately.

- Approval of November 4, 2015 Minutes
 - After discussion of the importance of Elected Officials and Department Managers clearly stating fiscal impact of actions being requested on Agenda Summary Reports for Board consideration, Commissioner Koch moved to approve the Consent Agenda. Commissioner Peck seconded and the motion was carried unanimously.

COUNTY ADMINISTRATOR KEITH JOHNSON

Office of Public Defense Interlocal Agreement (Resolution 2016-022): Mr. Johnson reminded the Board Benton Franklin Office of Public Defense (OPD) had been dissolved with each county now operating independent OPDs. Benton County had proposed providing OPD training to Franklin County legal staff through the end of April 2016 at an expense of \$10,500. He explained all Franklin County OPD records had been delivered the Administration office and procedures are being implemented.

Mr. Johnson has met with judges, state coordinators and Superior Court Administrator Pat Austin and had indentified three attorneys with the necessary qualifications interested in managing OPD for Franklin County. He felt Franklin County would better benefit from using the funds to set up our own OPD office, which could be up and running by April 1.

Mr. Johnson also informed the Board there appeared to be payment oversight for Involuntary Treatment Act hearings (ITA) to Benton County. He assured the Board he was researching the issue and would keep them informed.

- * After discussion, Commissioner Koch moved to approve Resolution 2016-022 creating the Franklin County Office of Public Defense and authorizing the County Administrator to establish necessary procedures to manage this function. Commissioner Peck seconded the motion carried.
- Re-keying Offices: Mr. Johnson informed the Board Franklin County Security was implementing a new keying system. In the past, there has been a designation of a Courthouse "general master" key. Definitions of keys and key distribution will change with the new keying system. Mr. Johnson explained it creates a significant liability for elected officials have keys to other elected officials offices. The new key distribution will limit liability and risk.

Commissioner Koch strongly felt Commissioners should have a "general master" key and, with cameras in every office, he didn't feel it would be a risk or a liability.

RECESS

Commissioner Miller called for a recess at 10:07 a.m., and to reconvene at 10:20 a.m.

RECONVENE

Commissioner Miller reconvened the Regular meeting at 10:20 a.m.

EXECUTIVE SESSION

RCW 42.30.110(1) (i) Potential Litigation Matter

Commissioner Miller recessed into Executive Session at 10:20 a.m., to discuss a potential litigation matter. He anticipated Executive Session to last approximately fifteen (15) minutes.

RECONVENE

Commissioner Miller reconvened the Regular meeting at 10:36 a.m.

Commissioner Miller asked about 911 services.

Commissioner Peck gave a brief overview of the process to date stating a grant had been applied for but was denied. With no grant funding, local funds were required. He explained the Committee was awaiting additional information before moving forward.

ADJOURN

With no further business to bring before the board, the meeting was adjourned at 10:39 a.m.
