#### LOBBYIST UPDATE

Zac Kennedy with Potts and Associates

Mr. Zac Kennedy via conference phone, explained House Bill (HB) 2842 and companion Bill Senate Bill (SB) 6580 addressed financing of improvements for state-owned lands to be transferred for private development. He explained the bill was still sitting and it was not seen by 5:00pm today, it would die.

Mr. Kennedy stated the first official hearing would be February 18, 2016 and he would keep the Board informed also addressed SB 6179 concerning water banking.

SB 6274 was concerning the Columbia River recreation salmon and steelhead endorsement program. He explained a public hearing was scheduled for February 18 in the House Committee on Agriculture & Natural Resources and he will keep the Board apprised of the outcome.

#### **PUBLIC WORKS BUSINESS**

Resolution 2016-065 Authorizing Public Works to Procure Win-Cams from Cascade Software Systems, Inc., of Eugene, Oregon

Public Works Director Matt Mahoney explained his department is committed to improving performance in a resource constrained environment and an extensive preliminary research of necessary software solutions had been completed. He explained the fiscal impact would be approximately \$115,170.10 and would be proportionately paid through County Roads, Motor vehicle and Soled Waste Funds. He added the entire project cost was included in the 2016 budget.
