<u>Digital Finger Printing/Scanner Grant</u>: County Coroner Dan Blasdel explained to the Board a grant may be available for a new digital finger printing scanner for an estimated cost of \$3500 for five (5) scanners. They are approximately the size of an i-Phone and have the ability to make fingerprints available in the system within one hour. Mr. Blasdel stated the grant was submitted March 18, 2016.

Joint Resolution with Benton County for Superior Court Salaries:

Mr. Johnson stated he was working closely with Benton County Deputy Administrator Loretta Smith-Kelty on Juvenile Justice Center and other bi-county contracts and felt the future relationship between Benton and Franklin Counties would be more positive. He stated Franklin County has always wanted to pay its fair share and reasonable cost.

The Board thanked and appreciated Mr. Johnson's hard work.

* After discussion, Commissioner Koch moved to approve the Joint Resolution with Benton County for Superior Court Salaries. Commissioner Miller seconded and the motion was approved 2:0 (Resolution 2016-126)

Superior Court Judge Cameron Mitchell also thanked Mr. Johnson for his dedication and hard work under trying circumstances and appreciated his professionalism.

- Sign Janitorial Services Contract Letter: Mr. Johnson explained a Notice of Termination was previously submitted to ABM Janitorial Services with a termination date of April 1, 2016. After discussions between Benton County and Franklin County staff, it was found and determined it was in the best interest of the counties to terminate the Contract effective March 31, 2016. Mr. Johnson presented a letter stating same and recommended the Board approve the new termination date.
 - Commissioner Koch moved to authorize the Board Chair to execute the Joint County letter terminating the contract with ABM Janitorial Services effective March 31, 2016. Commissioner Miller seconded and the motion was approved by a 2:0 vote.
