PUBLIC COMMENT

Mr. Hector Alanillo addressed the Board regarding several vehicle accidents and speeding issues along Wernett Road near Road 48. Mr. Alanillo requested the Board approve the installation of speed tables to reduce these issues in his neighborhood.

The Board acknowledged this was Mr. Alanillo's second time addressing the Board with these particular concerns and asked Public Works Director Matt Mahoney if his department had researched options for this area. Mr. Mahoney explained he had researched the issue and stated the installation of speed tables would be an in-depth process and not as nearly simple as it may sound to the public. Due to impact the installation, Mr. Mahoney recommended both City of Pasco and Franklin County officials make the decision after considering the impact of the installation. Mr. Mahoney was asked to bring a rough estimate of expenses associated with installation of speed tables on Wernett back to the Board, along with a history of accidents in the area.
