Noxious Weed Control Board Coordinator Todd Harris presented the Board with review of the 2016 year and budget.

In the past year 3079 miles of roadside spraying have taken place twice. Mr. Harris has used a new mixture that has been successful with Russian thistle. Tack weed has been kept under control except in areas that are irrigated, as the water dilutes the application.
