Franklin County Commissioners:

Commissioner Koch moved to approve Fund Expenditures audited and certified by the auditing officer for warrants prepared for the week of November 8, 2016 for payment of payroll totaling \$436,619.48. Commissioner Peck seconded and the motion was unanimously carried.

ADMINISTRATION OFFICE BUSINESS

After discussion on Compensation of County Officials and Staff, the following Resolutions were voted upon.

- * Commissioner Peck moved to approve the 2016 Cost of Living Adjustment for Non Bargaining Employees and Elected Officials, Resolution 2016-419. Commissioner Koch seconded and the motion carried.
- * Commissioner Koch moved to approve the 2017 Cost of Living Adjustment for Adjustment for Non-Bargaining Employees and Elected Officials, Resolution 2016-420. Commissioner Peck seconded and the motion carried.

County Administrator Keith Johnson clarified the reason for moving the meeting to November 8, 2017. Mr. Johnson recently became aware of the deadline for setting the Commissioners' salaries. After consulting with the Prosecuting Attorney and MRSC, the deadline for changes in the Commissioners' salaries needed to take place prior to Election Day or risk the salaries returning to the statutory minimum. The existing law prohibits Commissioners salaries to change during their elected term of service.

- Commissioner Koch moved to approve Franklin County Commissioners District 1 and 2 Salaries for 2017-2020 Resolution 2016-421. Commissioner Peck seconded and the motion carried 2:1.
- * Commissioner Peck moved to approve Resolution 2016-422, 2018 Cost of Living Adjustment for Adjustment for Non-Bargaining Employees and Elected Officials. Commissioner Koch seconded and the motion carried.

Commissioner Miller recessed the meeting at 10:09 a.m. until 9:00 a.m. Wednesday, November 9th, 2016 for Public Hearing.

Commissioner Miller reconvened the regular meeting at 9:00 a.m. Wednesday, November 9th, 2016.

Commissioner Peck let the Board know that he did know one of the parties in the Public Hearing, Mr. Lenk. Commissioner Peck also expressed that he could be fair and impartial in the Hearing but if either party felt there was a problem, he would remove himself. Both parties agreed to keep Commissioner Peck in seat for the hearing.

PUBLIC HEARING

Commissioner Miller recessed into the Public Hearing at 9:05 a.m.

Consider an Appeal of an Administrative Decision Regarding Short Plat 2016-19 an Application to Divide Approximately 4.6 Acres into Five (5) Residential Lots.

Planning and Building Director Jerrod MacPherson and Planning and Building Assistant Greg Wendt presented the Board with maps to view as they discussed the issues relating to Mr. William Dawkins trying to subdivide his property.

The Planning department had approved this short plat with 7 findings of fact and 5 conditions of approval. On October 12, 2016 the Planning department received an appeal letter from Mr. Roger Lenk.

Both parties were able to present their findings to the Board. After discussion on County laws, wells, easements, power lines and roads, Commissioner Miller closed the Public Hearing at 10:08 a.m.

Commissioner Koch moved to approve Resolution 2016-423 denial of appeal of County Planning Departments' decision to approve Short Plat 2016-19. Commissioner Peck seconded and the motion carried.
