- o Commissioner Peck referred to Senator Warnick's bill 5239 on the Hurst decision. In speaking with others, he felt that the bill was going in the right direction and is being addressed.
- o Pasco City Council had a discussion on taxi-like Uber services. The County does not have any policies in place that would forbid the use of these services. Uber is welcomed to provide services in Franklin County.
- O Commissioner Peck has been working with Representative Bill Jenkins on bill 1321 to arrange language to clarify the uses of buildings permitted, thus dispelling the conflict of competition. Commissioner Peck has disclosed that he has been working on this as a private citizen.
