### **CALL TO ORDER**

Commission Chairman Robert Koch called the Franklin County Commissioners' Regular Board Meeting to order at 9:00 a.m., in the Commissioners' Meeting Room in the Franklin County Courthouse located at 1016 North 4th Avenue, Pasco, Washington.

Commissioners Present: Commission Chair Robert Koch, Chair Pro Tem Brad Peck and Member Rick Miller

Staff Present: County Administrator Keith Johnson, Sheriff Jim Raymond, Captain Rick Rochleau, Auditor Matt Beaton, Human Resources Director Carlee Nave, Chief Deputy Treasurer Andrew Hicks, and Clerk to the Board Karin Milham

### PLEDGE OF ALLEGIANCE

Commissioner Koch led the Pledge of Allegiance

### **PUBLIC HEARING**

TRAC Director Tom French had received two significant invoices that came in unexpectedly. The first invoice is a fourth quarter unemployment charge of \$6,350.00. The second invoice is from a financial audit of \$1,443.00 from Administrator's office.

Commissioner Koch recessed into a Public Hearing at 9:02 a.m., to hear testimony for or against TRAC's 2016 budget revisions. There were no public comments for or against the revision.

Commissioner Peck stated that this was a modest increase to cover reasonable changes and expenses. The increase in the expenditures is \$15,000.00 but TRAC revenues this year exceeded the \$190,750.00 budget.

Commissioner Koch closed the Public Hearing at 9:04 a.m.

Commissioner Peck moved to approve Resolution 2017-38 to Increase the Revenue and Expenditure Bottom Lines of the 2016 Miscellaneous Franklin County TRAC Facility Fund, Number 405, by \$15,000, from \$2,489,056 to \$2,504,056. Commissioner Miller seconded and the motion carried.

## BENTON-FRANKLIN COUNCIL OF GOVERNMENTS PRESENTATION

Executive Director Brian Malley addressed the Board with the purpose of BFCG and reviewed the 2016 Annual report. Benton-Franklin Council of Governments primary role is transportation planning.

BFCG has a large role in Community and Economic Development as well. BFCG has two loan programs within the agency. The first is Columbia Regional Economic Development Trust and the second is Regional Revolving Loan Fund. Women and Minority Microloan is also a new program BFCG has started. Through these loans we can strengthen the community and economy.

# RESOLUTION 2017-39 NEW SHERIFF SALARY SCHEDULE PLACEMENT DISCUSSION

Human Resource Director Carlee Nave and Sheriff Jim Raymond presented the Board with Resolution 2017-39 proposing the Sheriff's compensation be removed from the Non-Bargaining Salary Matrix proposed by the Hay Group and putting it on the Sheriff's Non-Bargaining Salary Matrix scale.

- ❖ After extensive discussion, Commissioner Koch moved to approve Resolution 2017-39. There was no second and the motion died.
- \* After further discussion, Commissioner Peck moved that it be the policy of Franklin County that Elected Official compensation be determined by the Board of Commissioners in accordance with Washington State law at the time of such consideration and Elected Officials compensation not be placed on any salary matrix and for the County Administrator to bring forth a Resolution stating this policy. Commissioner Miller seconded and the motion carried unanimously.

Sheriff Raymond verified that the Board had just put forth a directive for a non-bargaining wage study that moved Elected Officials out of the study.

Commissioner Peck confirmed that was the intent and affect of the motion but doesn't preclude the Board from discussing or acting upon compensation for any Elected Official.
