### CALL TO ORDER

Commission Chairman Robert Koch called the Franklin County Commissioners' Regular Board Meeting to order at 9:00 a.m., in the Commissioners' Meeting Room in the Franklin County Courthouse located at 1016 North Fourth Avenue, Pasco, Washington.

Commissioners Present: Commission Chair Robert Koch and Member Rick Miller; Chair Pro Tem Brad Peck was excused.

### APPROVING NEW SALARY SCHEDULE FOR SHERIFF

County Administrator Keith Johnson presented the Board with Resolution 2017-95 to remove the Sheriff from the Non-Bargaining Salary Matrix and place him on a ten percent above Grade 20 Step 7 of the Sheriff's Non-Bargaining Salary Matrix.

After brief discussion the Commissioners moved forward with a motion.

\* Commissioner Miller moved to approve Resolution 2017-95 removing the Sheriff from the Non-Bargaining Salary Matrix and placing him on a ten percent (10%) above Grade 20 Step 7 of the Sheriff's Non-Bargaining Salary Matrix. Commissioner Koch seconded and the motion was approved 2:0.

#### **ADMINISTRATION OFFICE BUSINESS**

O County Administrator Keith Johnson presented the Board with a request for additional administrative staff in the Administrators' and Commissioners' office. Because of the large workload, it requires the current staff to work overtime and accrue comp time on a regular basis.

The Board of Equalization was a large task this past year with many petitions requiring a timely response and setting up hearings which required an extensive amount of time.

We also have a liability of records that need purging in effort to keep in compliance with the Public Records Act. Commissioner Koch agreed that the Administrative Office needed a permanent Public Records staff member to keep up with the many requests.

Commissioner Miller moved to approve Resolution 2017-99 Approval for additional office assistant in the Commissioners' Office and Administration. Commissioner Koch seconded and the motion carried 2:0.

O Mr. Johnson discussed some ways in which he and Human Resources Director Carlee Nave could complete the County-wide job description and compensation survey the Commissioners had requested. It has been a number of years since the Haygroup study had been done and it requires review and changes. Ms. Nave put together a proposal to engage the services of a consultant to help us acquire the data that is needed to make necessary changes.

Commissioner Koch and Commissioner Miller agreed and gave Mr. Johnson permission to move forward with this task.

O Benton-Franklin Counties Human Services Director Kyle Sullivan met with the Benton County Board yesterday and reported his findings to the Franklin County Board. Mr. Sullivan spoke with Benton County Commissioner Jerome Delvin and Kadlec Regional Medical Center's Chief Operating Officer Lane Savitch. Mr. Savitch suggested that Kadlec and other area hospitals would like to offer help in the process of finding a way to work with Mr. Weaver and Mr. Evans to assist with the Mental Healthcare proposals. Mr. Savitch is scheduled to introduce his proposal at Benton County's next Commissioner Meeting. Mr. Savitch would also like the opportunity to present his proposition to Franklin County Commissioners in the near future. Commissioner Miller and Commissioner Koch agreed that they would like to hear Mr. Savitch's suggestions.
