### CALL TO ORDER

Commission Chairman Robert Koch called the Franklin County Commissioners' Regular Board Meeting and Public Hearing to order at 9:00 a.m., in the Commissioners' Meeting Room in the Franklin County Courthouse located at 1016 North Fourth Avenue, Pasco, Washington.

### PUBLIC WORKS DECLARING SURPLUS OF COUNTY OWNED PROPERTY

Public Works Director Matt Mahoney worked with Sheriff Jim Raymond and Assessor Steve Marks to determine which County owned items would be declared as surplus and sent to auction for their disposal. There are seven vehicles from Public Works and four vehicles from Sheriff's office that will be sent to auction. Auction will take place on Saturday, November 4, 2017 at Booker Auction 31 Eltopia, West Road Eltopia, Washington.

Commissioner Koch recessed into a Public Hearing at 9:02a.m., to hear testimony regarding authorization for Franklin County Public Works Department's Declaration of Surplus Equipment/Items and Disposal Approval.

With no further testimony from the public, Commissioner Koch closed the Public Hearing and reconvened the regular meeting at 9:04 a.m.

Commissioner Miller moved to approve Resolution 2017-321, Authorization for Franklin County Public Works Department's Declaration of Surplus Vehicles and Disposal Approval. Commissioner Koch seconded and the motion carried.

# FRANKLIN COUNTY NOXIOUS WEED CONTROL BOARD 2018 BUDGET AND YEAR END REVIEW

Noxious Weed Control Board Coordinator Todd Harris presented the Board with review of the 2017 year and 2018 budget.

In the past year 3079 miles of roadside spraying have taken place twice. Mr. Harris has used a new mixture that has been successful with Russian thistle. Tack weed has been kept under control except in areas that are irrigated, as the water dilutes the application.

A brief discussion of the budget, employees, and salaries were discussed.

\* Commissioner Miller moved to approve Resolution 2017-321, the adoption of 2018 budget for the Franklin County Noxious Weed Control Board. Commissioner Koch seconded and the motion carried.

### **MIRROR MINISTRIES**

Executive Director Trisha MacFarlan presented the Board with an update on the progress of Mirror Ministries and their efforts to work with other sources to assist the victims of human trafficking. Ms. McFarlan displayed a PowerPoint presentation with statistics from the Tri-Cities area.

Mirror Ministries is a local 50lc3 nonprofit working with victims of human trafficking and we are an active member of Tri-Cities Coalition Against Trafficking. Mirror Ministries' mission is to respond to domestic sex trafficking with the love of Christ through local intervention, education, restoration, and aftercare.

Our current caseload averages 30 active clients per month. We also see an average of 5 new clients calling in on the hotline each month. Out of September's 32 active clients, 11 of them were Franklin County residents. Franklin County Prosecutor's Office and Pasco Police Department have enacted protocols and received training to help us serve these victims better. We are encouraged by their desire to always strive towards best practices for our community and look forward to continuing to partner with them. Having an advocate alongside a victim of sex trafficking from the beginning is considered 'best practice' for both their welfare and the potential of gaining evidence to prosecute their offenders and traffickers.

### EMPLOYEE SERVICE AWARDS POLICY

Human Resources Director Carlee Nave presented the Board with a revised resolution as instructed by the Commissioners in the October 18, 2017 meeting.

During the meeting, Board members expressed a desire to discontinue the safe driving awards because they are not accessible to all job categories, as well as the attendance awards due to the non-compliance with upcoming legislation. The Board directed HR to draft an updated policy preserving the length of service component of the awards program and addressing some of the administrative concerns raised.



Commissioner Miller moved to approve Resolution 2017-309, adopting the Employee Service Awards Policy. Commissioner Koch seconded and the motion carried.
